The links will only be accessible to members who will have booked and paid for the webinars before the advertised deadline. The links will be sent to members through the email address listed in the LSK database and are accessible through the member's portal as well.

To access the webinar registration links on the portal, members will have to log in to their accounts and go to open CPD events. The webinar link option appears on the booked event as in the first image below. Alternatively, members can go to "CPD Events" then "My CPD Events" the webinar registration option will appear on the booked event as in the second image below.
