

### LSK COUNCIL PAYS A COURTESY CALL TO THE OFFICE OF THE SPEAKER OF THE SENATE

The LSK Council led by the President, Mr. Eric Theuri paid a courtesy call on the Speaker of the Senate, Hon. Amason Jeffah Kingi EGH at his Senate Offices on Thursday 8th June 2023 accompanied by Council Members and the Deputy CEO.

In line with Society's mandate under Section 4, the President flanked by Vice President Faith Odhiambo, presented a memorandum to Hon. Kingi. The memorandum addressed issues that are pertinent to the Society while making a raft of recommendations for further deliberations by the Office of the Speaker of the Senate and the Council of the Law Society of Kenya as well as areas of intervention which included legal reforms; public participation; Legal education and legal aid clinics; capacity building of county assemblies and provision of tracked copies of bills in every stage of discussion in Senate amongst other issues.

The Council noted the significant strides made in the development of numerous legislations and appreciated the Senate for their hard work and hoped to collaborate with a view to further improve the legislative process.

## STAKEHOLDER ENGAGEMENT FORUM ON THE DEVELOPMENT OF A REGULATORY FRAMEWORK FOR ACCREDITATION OF PARALEGAL EDUCATION AND LICENSING GUIDE

The Law Society of Kenya- through its Compliance and Ethics Directorate participated in the Stakeholders' Validation Forum held on May 30th -31st, 2023, at the Tamarind Tree Hotel, Nairobi, on 'Development of a Regulatory Framework for the Accreditation of Paralegal Education and Licensing Guidelines' hosted by Council of Legal Education and International Development Law Organization (IDLO).

The Stakeholders' discussions were geared towards the creation of a regulatory framework for the accreditation of Paralegal Education in Kenya and the creation of a curriculum for paralegal education.

The Stakeholder's discussions were spearheaded by Prof. Githu Muigai, EGH, SC - Chairman Council of Legal Education, Ms. Mary M. Mutugi, OGW- Secretary/CEO-CLE and the Representative from IDLO. They steered the discussions towards the creation of a curriculum for paralegal education amongst others.

Day one of the engagement forum saw Prof. Kulundu Bitonye, present on the understanding of paralegalisms, the definitional dilemma, the history of paralegalisms, the types of paralegals (Community-based versus Professional/Commercial paralegals), the regulatory framework governing paralegals and the need for standardization of paralegals in Kenya. Dr. Peter Nyaga did a presentation on mapping and the report on the current state of paralegals and organizations undertaking training thereof.

The second day was facilitated by Ms. Florence Shako who took the participants through the proposed curriculum - broken down into four modules of 24 courses in total.

The Plenary covered the stakeholders' recommendations with LSK's first recommendation being to have a separate curriculum for Community-based Paralegals from the Professional Paralegals since the proposed curriculum seems to favor the latter, that there be a clear demarcation on the institutions to train the two categories and that further the 24 courses being proposed be minimized for easy digest. Currently, the Society is preparing a Memorandum on the same and members will be invited to submit their comments in due course.

The Law Society of Kenya secretariat hosted a team from the National Council for Law Reporting (Kenya Law), led by the Editor/ CEO, Prof. Jack Mwimali, on Wednesday, 7th June 2023. Other members present in the meeting from Kenya Law included Ms. Janet Munywoki (Deputy CEO/ Senior Assistant Editor), Ms. Vivian Etyang and Ms. Wambui Kamau (Senior Law Reporters).

The meeting commenced with a brief by Prof. Mwimali highlighting the mandate of Kenya Law and emphasizing on its mandate on the revision of Laws which was recently delegated by the Attorney General vide Legal Notice no. 29 of 2009.

Through the delegated mandate, it is to undertake the preparation of an Annual Supplement of the Laws of Kenya as guided by sections 7 and 8 of the Revision of Laws Act, Cap.1 of the Laws of Kenya, and as well as the consolidation of the Laws in electronic form on hand on the Kenya Law website <a href="www.kenyalaw.org">www.kenyalaw.org</a>.

Prof. Mwimali further noted that in the process of incorporating legislative developments and reviewing obsoleteness in form and structure, there was created the need for public participation in the 24th Annual Supplement thus calling on the Law Society of Kenya to aid in sensitizing the members on the same as part of public participation.



The Society is willing to partner with Kenya Law to engender public participation and sensitization of its members on the same. The meeting was concluded with an appreciation of the various opportunities both institutions can collaborate in to uphold the rule of law.



Lawyers across the world are guided by set out rules of standards set forth in codes of conduct and privileges, ethics, and rules of professional conduct that are established by state bar associations.

The Practice Standards and Ethics Committee are mandated By the Council of LSK to provide support and advice on interpretation, management, and best practices in relation to ethical values, professional principles, and standards as appropriate the committee notes that the issues of quacks and practice by unqualified persons have become rampant. The committee through its members Joy Mukuhi, Karanja Meru, and Lydia Abala had a webinar to discuss ethical practices in Kenya.



The members were also appraised on the liaison process between the branches and the LSK Secretariat. The LSK branches work in close collaboration with the Secretariat in ensuring law firms adhere to the rules in practice at the devolved level.

### INTERNET PRIVACY: A LAWYER'S GUIDE TO ONLINE PRIVACY (PART 2)

Following up on last week's article on how you can stay safe in this internet age, here are more ways to keep you on the straight and narrow:

• Avoid torrent or piracy web sites

He...he...yes. There is something called ET (Entertainment Theft) and by show of hands please, how many here are thankful for pirate bay for making campus worth it? Aye?... Just me then? Ah. Ok.

Here is what I will say about Entertainment Theft. Do not be the one breaching creator's rights on pirate bay and torrent, downloading pirated movies and music on to your phone or laptop. Because the same way the pirates stole and brought goods and information to you is the same way they will steal your information and sell it to someone else. Are we together?

• Install an antivirus security suite

It is normally a no brainer for laptops and desktops. However, mobile device will also benefit from enhanced antivirus protection as a last line of defense. The software will notify you when you are about to click on malware links or suspicious content.

• Rethink your social media presence

Find a sweet spot between your need to keep up with news and to catch up with friends through social media on one hand and also ensure that you do not compromise your own security and privacy. A tweak your privacy settings will give you control as to the levels of access to your information that you give out.

• Use caution when connecting to public Wi-Fi

The free Wi-Fi offered at coffee shops, public libraries, airports, and hotels is a nice convenience. It allows us to get our work done on the go. But public Wi-Fi also comes with risks and, if you're connecting to such a system, you need to be cautious.

The key problem with public Wi-Fi is that it can be easy for prying eyes to access any information you send and receive while online. When you're accessing public Wi-Fi, then, avoid doing anything that involves sensitive information, like entering your bank account password or credit card information. And never send personal information in email messages. If you do, strangers might be able to easily intercept that information.

#### HTTPS everywhere

Need to connect to your bank, credit union, or credit card provider? Make sure to check the web address in the top of your browser. If it doesn't start with "https," don't log in.

The "https" in front of a web address means that a website is secure and uses encrypted data. If a site's address starts with "http" instead - no "s" - that means the site is not secure. It could be easier for hackers to access and steal personal information or track your online activity if you are visiting unsecured sites.


The good news is that the HTTPS protocol is now standard. The web addresses of your bank, credit card provider, and other financial institutions should all start with it. If you log onto your bank and you don't see "https"? Do not open your account, and do not use the site to pay bills or transfer money.

#### • Opt out of personalized ads from Google

### DID THE FINANCE BILL 2023 BENEFIT FROM PUBLIC PARTICIPATION?

In the coming week, the Cabinet Secretary National Treasury and Economic Planning will be presenting the First Budget under the Kenya Kwanza regime. The Budget has been precipitated by a public debate on the 2023 Finance Bill. The 2023 Finance Bill seeks to amend various laws relating to taxes and duties with the goal of increasing government revenues from taxes collected. In doing this the government has proposed various measures that include increasing the tax bracket and the tax percentages. A bill of such magnitude is subject to public participation. The public finance framework under Articles 201, 221, and 232 of the Constitution requires that public participation be integrated into the consideration of financial matters. This has been the practice over the past years where the County Integrated Development Plan (CIDP) has had members of the public participate in the planning. In this process, Members of the public can therefore make submissions or attend public hearings to give their views on financial matters. This is in line with intent defined by the International Association for Public Participation which distinguishes it as the involvement of those affected by a decision in the decision-making process.

Being one of the foundational principles of democracy public participation is particularly important as the government lays out its financial plan in the first year of its five-year term. Citizens' participation in government decision-making is fundamental to the functioning of a democratic system of governance as stated in chapter one of the Constitution of Kenya 2010. Public participation has many benefits some of which are: citizen empowerment; the generation of new, diverse and innovative ideas and actions; enhancement of citizen-government relations; legitimation of government programs, appropriate prioritization of projects; improved delivery of public services and; government responsiveness. The importance of public participation is captured in Article 118 of the Constitution, which mandates Parliament to facilitate public participation and involvement in the legislative and other business of Parliament and its committees'. Citizen involvement in policy-making and implementation strengthens and deepens good governance. International and regional agreements, which Kenya is a signatory to, in public participation are spurring the government to take steps to improve transparency, participation, and accountability. At a global scale citizen participation is pronounced as part of integrating sustainable development in a country's development agenda.



#### CONTD...

Kenya Kwanza had emphasized this Bottom-Up Economic Model which is citizen-centric. It is therefore imperative that the voice of the public is part of the discourse in important legislation such as the Finance Bill 2023. It is therefore heart-warming to see the country abuzz with discussions as regards the contents of the Bill. The country has also been afforded the opportunity to see the Finance Committee of Parliament listening in to various stakeholders as regards their opinions on the Bill. This being a democratic process it is expected that the views and opinions of the public including the LSK would find their place in the Bill through proposed amendments. If this is not done, we would be ticking boxes in the legislative process.
