The Young Bar Council of England and Wales and Law Society of Kenya provisionally agreed to a remote 1:1 mentoring scheme, with a pilot programme that will see 10 lawyers from Kenya being paired with 10 barristers practicing in England & Wales.

The program will run for a period of approximately one (1) year, during which there will be matched with a mentor who will work closely with each of them to provide guidance, support and advice. 


### LORD CHIEF JUSTICE OF ENGLAND AND WALES VISIT TO KENYA

The Lord Chief Justice of England and Wales, the Lord Burnett of Maldon took time to visit the Kenya School of Law, where the students held a debate on the "Admissibility of Electronic Evidence in Criminal Courts in Kenya". The Chief Justice also delivered a public lecture on "Judicial Independence and Accountability in the 21st Century". A number of students got the opportunity to interact with him personally and seek professional advice on their career paths.

The Law Society of Kenya, in partnership with the Commonwealth Lawyers' Association, put together a panel of the Lord Burnett of Maldon and legal professionals from the Judiciary, the Senior Bar, the mid-Bar and the Young Bar in Kenya.

The panel consisted of Lord Chief Justice, Kiragu Kimani, SC, Dorcas Oduor, SC, Hon. Justice Isaac Lenaola, Hon. Justice John Chigiti, Catherine Mulika and Effie Achieng.











## LAUNCH OF THE ODPP ALL FOR JUSTICE PHASE II & ODPP MALALAMISHI SYSTEM

The LSK President joined the <u>ODPP</u>, together with other criminal justice actors, for the launch of the All for Justice Phase II project which is aimed at decongesting prisons, reducing case backlog and the Malalamishi Complaints and Case Review System which is aimed at enhancing efficiency in handling complaints and case reviews. The 2nd Phase of the All for Justice Programme aims to reduce case backlog and enhance efficiency in handling complaints & case reviews.

The focus of the <u>ODPP</u> to proactively review cases is not only welcome, but it is also much needed. Over 50% of imprisoned persons in Kenya are in pretrial detention. The devastation on their families is often irreversible even if they are acquitted.

The DPP has called upon stakeholders in criminal justice to partner with ODPP as it strives to review files for the 35,000 pre-trial detainees countrywide. He recommended the adoption of a "whole-of-society approach" to enhance restorative justice in society.

The Law Society of Kenya supports the efforts to decongest prisons at the All for Justice Phase 2 launch and the Malalamishi App at the Nairobi Remand and Allocation Prison.

#### COURTESY CALL TO THE MALINDI LAW COURTS

The Law Society of Kenya Council paid a courtesy call to the Malindi Law Courts on Friday, 19th May 2023. The Chief Magistrate Honorable Elizabeth Osui welcomed and thanked the Council for making time to visit the Courts. She highlighted the challenges experienced in the Courts, such as the insufficient number of secretaries currently in service.

The President, Eric Theuri, assured the Chief Magistrate of LSK'S willingness to support, particularly through the Branch and Chapter. He went on to commend the Court for its level of efficiency. He also encouraged the fostering of a positive relationship between the Bar and the Bench.

The Chairman of the Malindi Chapter, Conrad Atiang guided the council to the Advocates' Lounge, where possibilities of relocation and the current state were discussed.









The Council then took time to interact with the members of the Malindi Chapter. With approximately 30 members present, the meeting kicked off with a luncheon and a presentation from Chair Conrad Atiang.

He also highlighted the need for a small claims court in Malindi and the security challenges experienced in practice.



Several concerns were tabled by members on the inconsistencies in the e-filing system and the role of the Society in Public Interest matters. The Council assured the members of their commitment to addressing all challenges raised during the Branch visits.

The Council then met members of the Mombasa Law Society that evening. The Chairman, Charles Opulu, opened the meeting with a few remarks on the empowerment of Branches to fulfill their mandate. Members also had the opportunity to express various challenges experienced in practice. However, they applauded the work done by the Coast Representative, Council member Riziki Emukule.

### LAUNCH OF THE INVENTOR ASSISTANCE PROGRAM IN KENYA

With support from the World Intellectual Property Organization (hereinafter referred to as WIPO), Kenya launched the Inventor Assistance Program (IAP) on 11th May 2023 at Ole-Sereni Hotel.



The World Economic Forum (WEF) and WIPO came together and developed the Inventor Assistance program which is an innovative program aimed at making the Intellectual Property (IP) System more accessible by matching financially under-resourced inventors with qualified IP agents who, assist in securing patent and utility model protection. The IAP Program has three pillars; innovate, protect and commercialize.



Kenya becomes the 9th IAP participating country, joining Chile, Colombia, Ecuador, Morocco, Peru, the Philippines, Singapore and South Africa. The Program pairs inventors with volunteer experts to navigate the <u>patent system</u> at no cost, increasing the odds of securing a commercial asset. More than 45 inventors have received patents with the Program's help so far.



Representatives from WIPO, Kenya Industrial Property Institute (KIPI), LSK, Ministry of Trade Investments and Industry (MITI) and Affiliated State Agencies, registered IAP Volunteers, Kenya National Federation of Jua Kali Association and various innovative university students graced the auspicious occasion.

Through the IAP, volunteers provide a free kick-start to the use and development of the patent system in the IAP participating countries. Their work helps spur innovation at the grassroots level and also allows them to develop their professional skills in new, rewarding ways.

### INTERNET PRIVACY: A LAWYER'S GUIDE TO ONLINE PRIVACY (PART 1)

Did you know that most Internet Service Providers (ISPs) are tracking, storing and mining your online activity? As it is, information is the most powerful and most valuable machinery for business today, so do not be surprised that web browsers will, depending on various authorizations and settings, collect browsing data and sell it to third parties. A simple Google search is a key indicator to what you do for a living, how much you earn, where you live and what your current intentions are, all of which is valuable information.

That doesn't mean that you should toss your digital devices. Not only would that be unrealistic, but it would also mean giving up the benefits of digital technology. Just to balance off data safety and the convenience provided by digital devices, here are action points you can take to control the nature of information that is accessible to third parties.

#### 1. Secure your Wi-Fi network and router

Take this step immediately after setting up a new router in your home or office: Change your username and password. Why? Many routers come with both a default username and password which is standard and easy to know if a hacker really wanted to infiltrate your system.

#### 2. Use a VPN (Virtual Private Network)

Another important step in protecting your online privacy is to use a secure virtual private network, better known as a VPN. A VPN keeps the data you transmit and receive over your Wi-Fi connection private. When you search online, your computer will connect to this private server first before it connects to the web. This keeps your browsing private.

Some of the best VPNs in Kenya include Cyberghost, NordVPN, Surfshark and IPVanish all of which have a wide range of security including non-log options, fast speeds and unblocking abilities.

#### 3. Use browsers that don't track your search history

Did you know that your data is tracked while browsing on Google Chrome, Firefox of Internet explorer? Even searching in incognito or private mode won't keep your searches completely private, because your employer, the ISP (Internet Service Provider) and the websites you visit can still track you.

There are browsers that do keep your online activity private, <u>Tor Browser</u> being the most famous. Others like Brave Browser and Epic Privacy Browser have also been known to maintain high levels of privacy.

#### 4. Use a screen lock to help protect your devices

Screen lock and password protecting your devices blocks access to your sensitive information stored in your phone, laptops and other devices, should the device land in the hands of an unauthorized person. With a phone lock, you phone is not open to hacker during downtime (idle time) and it cannot be manipulated during those times.

#### 5. Clear your browser's search history and clear Cache

Your web browser will store your searching history indefinitely and crucial information may be mined out of your browsing history. Fortunately, deleting your search history is a simple step. You can usually erase your digital footprint history by visiting the history section on your browser and choosing what levels of history you wish to erase.

#### 6. Turn off "Location Services" on your devices

Many of the apps on your phone or tablet will track your location. This is just another example of how our favorite devices can intrude upon our privacy. Apps can use or sell FEATURE BY this information to make us better targets for advertisers.

More than that, intruders can check and track you in person based on your devise location which not only compromises you privacy but also your security. The reality however is that you will need location services especially when using Google maps, in which case, just activate location specifically for that task and then turn it off afterwards.

## NOTICE FOR COMMENTS ON THE REPORTING GUIDELINES FOR PUBLIC ENTITIES AND PRIVATE BODIES UNDER THE ACCESS TO INFORMATION ACT, 2016

The Commission on Administrative Justice established under Article 59(4) of the Constitution of Kenya and the Commission on Administrative Justice Act, has in partnership with GIZ developed Guidelines for reporting by entities and private bodies. The mandate of the Commission is to oversee and enforce the right of access to information as provided for under Article 35 of the Constitution and the Access to Information Act, 2016.

The purpose of the Reporting Guidelines is to: -

- i. Provide a standardized framework for reporting by public entities and relevant private bodies:
- ii. Guide public entities and relevant private bodies to provide certain information on a regular basis in a standardized method;
- iii. Harmonize information reported by public entities and relevant private bodies;
- iv. Ensure institutional compliance with the law;
- v. Enable identification of access to information implementation challenges and find ways of addressing them.




