## VALIDATION OF A COMPENDIUM ON KENYA 2022 ELECTION CASES

The Law Society of Kenya (LSK) and Uraia held a validation exercise on the compendium of Kenya 2022 Elections bringing together various stakeholders including Civil Society Organizations (CSOs), Legal Practitioners and media amongst others.

The LSK and Uraia have long been advocates of civic education and a transparent democratic process in Kenya. Understanding the significance of fair and transparent elections, both organizations have come together to develop a compendium on cases emanating from the 2022 elections that will be an invaluable resource for legal practitioners and members of the public.

The compendium covers a wide range of cases that highlight issues such as electoral management and political parties dispute resolution mechanisms. The compendium is a critical tool in jurisprudential development and legal reform.

The compendium's availability and dissemination and additional initiatives aimed at promoting an inclusive and transparent electoral process will be shared in subsequent newsletters .

## GREEN WEEK IN KENYA: WHAT DID YOU TAKE HOME?

**“The current climate change comes from global warming caused by human actions.”**



This week Africa and Kenya have been served with heavy doses of the Climate Change, Climate Justice thematic Topic. It is quite refreshing that this comes close on the heels of the LSK Annual Conference 2023 which had Climate Change as the main topic for discussion. It is therefore important that we continue to engage in the topic that is fast changing the African policy direction in terms of social and economic development. As advocates we have to sharpen our knowledge on the topic firstly for our intellectual wellbeing, second for our business regeneration and sustainability, and lastly for our social banter. We want to be knowledgeable and approachable in the topic to make it work for us. It is in this regard we focus on the common terminologies that have been abuzz this week with the African Climate Summit 2023.

**CLIMATE JUSTICE:** Links human rights and development in order to achieve a people-centred approach, protecting the rights of those who are most vulnerable to the effects of climate change. The concept also proposes that the burdens, impacts, and benefits of climate change be shared in an equitable and fair manner. Climate justice responds to science and also recognizes the need for an equitable 1 distribution of the world's resources.

**CLIMATE CHANGE:** A change in the state or variability of the climate. Climate change is identified by variability in climate properties that persist for a prolonged period and can be identified through statistical tests. Climate change may be caused by natural internal processes or by external forces, such as volcanic eruptions, tsunamis, or persistent anthropogenic actions.

**CLIMATE VARIABILITY:** Climate variability refers to variations in the average state of the climate, on all temporal and spatial scales, that exceed the typical scales of weather events. Climate variability may be natural or anthropogenic.

**GLOBAL WARMING:** The current climate change comes from global warming caused by human actions. This warming refers to an increase in global temperature that has been recorded over a period of 30 years or more. It is generally expressed in relation to the levels that existed before the Industrial Revolution.

**GREENHOUSE GASES:** The gaseous component of the atmosphere, which may be natural or anthropogenic. Greenhouse gases absorb and emit radiation, which causes the greenhouse effect. The primary greenhouse gases are: 1 Water vapour (H<sub>2</sub>O) 2. Carbon dioxide (CO<sub>2</sub>) 3. Nitrous oxide (N<sub>2</sub>O) 4. Methane (CH<sub>4</sub>) 5. Ozone (O<sub>3</sub>) There are also other greenhouse gases in the atmosphere; these are anthropogenic in origin, such as halocarbons, which consist of carbon and certain halogens such as chlorine bromine, fluorine and hydrogen.





## WEEKLY BITES

**CLIMATE RISK:** Ability to respond and adapt. The potential for adverse consequences of indeterminate scale that endanger something of value. The risks depend on: 1. Vulnerability: predisposition to be adversely affected. Vulnerability is determined by sensitivity to damage and the lack of capacity to respond and adapt. 2. Exposure: a condition in which the system is exposed to the climatic phenomenon or trend. 3 Hazard: a natural or human-induced event that may cause adverse effects on systems.

**CLIMATE IMPACT:** The consequences of climate change on social and economic aspects, ecosystems and species. Economic, social, and ecosystem goods and services are also affected. These impacts may be adverse or beneficial. They may be seen as consequences or results of climate change

**CLIMATE GOVERNANCE:** Voluntary mechanisms and measures aimed at directing social systems towards preventing, mitigating or adapting to the risks of climate change. Climate governance also enables social actors to participate in the different decision-making processes and the implementation of climate actions. Climate governance should be seen as a "multi-level" process that includes the Local through communities; National through countries; International through region or involving multiple countries

**MITIGATION:** Human actions that seek to reduce greenhouse gas emissions, for example eliminating the burning of fossil fuels. Mitigation also refers to actions that enhance sinks of greenhouse gases, for example conserving mangrove ecosystems, which are considered sinks.

**SINK:** A sink is a reservoir where greenhouse gases are stored. They may be natural or the result of human activity in land and marine ecosystems. Oceans and forests are examples of natural sinks, while sinks resulting from human activity are linked to processes such as reforestation.

**CARBON MARKET:** A trading system in which reduced emissions or captured concentrations of greenhouse gases are traded, exchanged, bought and/or sold. Markets are important because they regulate and balance emissions. There are two types of markets: 1. Regulated carbon market: regulated by mandatory national, regional or international carbon reduction guidelines. 2. Voluntary carbon market: markets that trade in carbon reduction but are outside official and mandatory requirements

**ADAPTATION:** The process of adjusting human systems to the actual or expected climate and its effects. Adaptation aims to moderate damages or take advantage of beneficial opportunities. Natural systems can also adapt, and human intervention may facilitate this adjustment process

**ENVIRONMENTAL DEMOCRACY:** The participation of social actors is important and needed to guarantee that interests in environmental decisions are considered from an adequate and equitable approach. Environmental democracy encompasses the rights of access to environmental information, environmental justice and participation in 21 environmental decision-making spaces. The Environmental Democracy Index monitors the progress of countries in establishing regulations to promote transparency, access to justice and citizen participation in environmental decision-making.

**ACCESS RIGHTS AND CLIMATE GOVERNANCE:** Access rights are: 1. the right to participate in decisions on climate change, 2. the right to information on climate change, 3. the right to justice in matters related to climate change.

## Our 6 step process on how to issue a notice of intention for taking out a Practicing Certificate Under Section 25 Advocates Act Cap 16

- 1 Write a letter to the Chief Registrar of the Judiciary, indicating the reasons for not taking out the PC. Attach necessary supporting documents and a duly commissioned statutory declaration. This should be in duplicate.
- 2 Have the letter received and stamped at the Advocates' Section, Room 61 and thereafter share with us the stamped copy.
- 3 The Notice is then placed before the Council for consideration.
- 4 The Council decision shall thereafter be communicated to members, through the provided email and post office address.
- 5 Upon fulfilment of the provided conditions by the Council, the applicant shall proceed to apply for the current year's Practicing Certificate.
- 6 Right to appeal if aggrieved by the decision of the Council and with valid grounds. Provide sufficient documents.



This applies to advocates who have not taken out practicing certificates for more than twelve months.
