LSK COUNCIL CALLS ON THE THIKA & KIAMBU CHAPTERS AND NAIROBI BRANCH MEMBERS





MEMBERS CONVERGE FOR A SPECIAL GENERAL MEETING

Members converged virtually for a Special General Meeting on Friday 17th November 2023 to discuss the two-point agenda item which included Elections of six members to serve in the Elections Board for the elections of the LSK Council, LSK Male Representative and Members of the Advocates Disciplinary Tribunal and to Consider the report of the LSK Development & Investment Committee on the Optimization of the Law Society of Kenya Properties.

The meeting whose attendance was at 3,450 members present, was spearheaded by the LSK Vice President Ms. Faith Odhiambo flanked by other Council Members and the LSK CEO Ms. Florence Muturi, discussed the agenda items conclusively to a vote as follows; Members voted in the shortlisted candidates for the elections board and the following members were appointed;

On the agenda to Consider the report of the LSK Development & Investment Committee on the Optimization of the Law Society of Kenya Properties, members passed the key resolution as follows:

- Adoption of Highest Best User (HBU) Reports: That the HBU Full Report, the HBU Summary Report, and the LSK's Membership-Informed Symphony, be adopted as the foundational documents guiding the future development of the aforementioned land parcels.
- Mandate for Setting up Special Purpose Vehicles (SPVs): That the LSKDIC and the Council be authorized to explore and establish Special Purpose Vehicles (SPVs) aligning with the HBU reports' objectives.

- Proposal of Development Levy Modalities: That the LSKDIC and the Council be mandated to propose modalities for the establishment of a Development Levy, aligned with the objectives outlined in the HBU reports.
- Engagement with Stakeholders: That the recruitment of experts and consultants follow a transparent, competitive process in line with the HBU summary report, ensuring fairness and accountability.
- Fiscal Responsibility and Contingency-Based Agreements: That the LSKDIC and the Council are authorized to engage in contingency-based agreements, subject to scrutiny by the general membership, ensuring financial prudence and responsibility.
- Special General Meeting (SGM): That a future SGM be convened to consider and adopt detailed plans and agreements necessary for the project's realization, aligning with LSK's vision.
- Extension of LSKDIC Mandate for Project Maturation: That the Law Society of Kenya extends the term of the LSKDIC for an additional three (3) years. This extension aims to ensure continuity and strategic stability for the effective implementation and completion of the Society's development project.

This momentous occasion stands as a testament to LSK's unwavering dedication to the law, justice, and innovation. It marks a visionary stride toward transforming not only its physical infrastructure but also its very core—an embodiment of the values that define and elevate the legal fraternity.



ABOUT THE COURSE

The public sector relies upon uniform public policies and guidelines as a tool to enhance efficient public administration. The process of policy formulation begins with identification of issues and the definition and formulation of suitable solutions. The most suitable policy solution is the output of rigorous planning, negotiation and robust stakeholder engagement in compliance with the Constitution. The biggest challenge after policy formulation is usually the implementation of public policy across different institutions and departments. Further, the implementation process must be closely monitored and evaluated to establish policy outcome and assess consistency with policy objectives. Effective and efficient future policymaking is dependent on a diligent examination of previous experiences and learnings.

This course offers participants an experiential and practical training on the entire public policy making process and aims to equip them with knowledge and skills to ensure policy formulation is consistent with institutional culture, mode of governance and landscape. They course will also highlight the key challenges in policy formulation, analysis and implementation.

TARGET AUDIENCE

This course is suited generally for all those involved in policy formulation and execution. The course would be specifically handy to: middle to senior staff in State corporations, Ministries, Commissions, County governments, legislators and their staff (the staff providing guidance/ procedural support in research, drafting briefs, policies, legislation, public participation, liaison between National and County level governments, committee functions, et cetera); private entities oversighting governance processes (NGOs, consultancies); etc.

COURSE OBJECTIVES

By the end of the course the participant will be expected to:

- 1. Show demonstrable skills on how policy is formulated, analysed, and implemented;
- 2. **Demonstrate** mastery of the key issues and steps in public policy formulation & analysis, including public participation, problem identification, etc.;
- Demonstrate a good grasp of the operational mechanisms in research, initiation, drafting and translation of policy into legislation;
- 4. Identify challenges and pitfalls in policy-making;



ADVOCACY DISCIPLINARY TRIBUNAL; KNOW YOUR TRIBUNAL



KNOW YOUR TRIBUNAL



ESTABLISHMENT

The Advocates Disciplinary Tribunal (ADT) plays a crucial role in upholding the standards of the legal profession in Kenya. The ADT is established under Section 57 of the Advocates Act, Cap 16.



MANDATE

The ADT is mandated to hear and determine complaints lodged against Advocates. The LSK Secretariat through the Compliance & Ethics Directorate, serves as the administrative arm of the Tribunal. It receives the affidavits of complaint from the Advocates Complaints Commission (ACC) and forwards them to the Tribunal members for prima facie determination. Once a case to answer is established, the Secretariat allocates the matters case numbers, sets them down for plea taking and undertakes service upon advocates. The Secretariat through the Compliance & Ethics Directorate also ensures advocates comply with orders of the Tribunal.

CONSTITUTION



The ADT is comprised of the Attorney-General, Solicitor-General or a person deputed by the Attorney-General, six advocates, the Chairman, Vice-chairman and the Secretary of the Law Society. The Secretary of the Society is the Secretary to the Tribunal.

KEY STAKEHOLDER



TThe Advocates Complaints Commission (ACC) operates in close coordination with the LSK and the Tribunal. The ACC is established under Section 53(1) of the Advocates Act. It is mandated to receive complaints of professional misconduct against advocates. The ACC works to promote reconciliation, provide amicable settlement through Alternative Dispute Resolution (ADR) and conduct investigations with regard to complaints lodged against advocates. Additionally, the ACC may refer and prosecute complaints of professional misconduct before the Tribunal, at no cost to the complainants.

WHO CAN INSTITUTE A COMPLAINT AGAINST AN ADVOCATE?

- Any member of the public aggrieved can lodge a complaint against an Advocate.
- An advocate can lodge a complaint against a fellow advocate.

WHERE DO I LODGE MY COMPLAINT AGAINST AN ADVOCATE?

 An aggrieved party can either lodge a complaint directly with the Advocates Disciplinary Tribunal or with the Law Society of Kenya or with the Advocates Complaints Commission.

HOW DO I LODGE A COMPLAINT AGAINST AN ADVOCATE?

- 1. Write a letter to the Law Society of Kenya lodging a formal complaint against the advocate. Ensure to include the full names of the advocate and have the complaint signed.
- 2. Alternatively, you may lodge a complaint through the Advocates Complaints Commission. You will be required to fill in the provided help form. Subsequently, the Advocates Complaints Commission will carry out investigations into the matter and lodge a complaint on your behalf, with the Advocates Disciplinary Tribunal.
- 3. You may also prepare six sets of Affidavit of Complaint under section 60 of the Advocates Act to be forwarded to the Tribunal for determination.

HOW DO I LODGE A COMPLAINT BEFORE THE ADVOCATES DISCIPLINARY TRIBUNAL?

Prepare six (6) sets of Affidavits of Complaint (Under Section 60 of the Advocates Act)

File the Affidavits at LSK

Service by the LSK to the accused Advocate (private prosecution)

Prima Facie Stage

Plea taking Stage

Hearing Stage (by affidavit evidence)

Judgement stage

Mitigation and Sentencing Stage

Enforcement of Tribunal Orders

ADVOCATES DISCIPLINARY TRIBUNAL SANCTIONS

Where a case of professional misconduct has been made against an advocate the Tribunal may order the following: the advocate be admonished; the advocate be suspended from practice for a specified period not exceeding five years; the name of the advocate be struck off the Roll of advocates; the advocate to pay a fine not exceeding one million shillings; or the advocate to pay to the aggrieved person compensation or reimbursement not exceeding five million shillings.

Who is an Advocate of the High Court of Kenya?

A person duly entered to roll of Advocates and has a practicing certificate for the current year.

You can check the practice status of such an advocate on online.lsk.or.ke by clicking on Search Advocate and entering the name of the advocate. If the Advocate has a valid practicing certificate(PC), it will be Active. If not, it will be Inactive.

In case an advocate is practicing without a PC, please report to director practice standards by compliance@lsk.or.ke or send a letter to LSK Secretariat.

Practicing without a valid Practicing Certificate is professional misconduct tantamount to disciplinary proceedings.

Who is a quack or Masquareder?

This is a person who pretends to be an advocate.

They can equally be identified by the above process. If a person is not entered in the LSK Portal, the person is a masquerader and criminal proceedings should ensue.
