## THE 2023 LEGAL AWARENESS WEEK OBSERVED

The Council of the Law Society of Kenya, through the Public Interest Litigation Committee, chaired by Mr. Mwaura Kabata, held the Legal Awareness Week 2023, under the theme: "Unlocking Justice: A Collective Effort To Decongest Prisons and Deliver Legal Aid" from Monday, 23rd to Friday, 27th October 2023.

The Legal Awareness Week was launched on Monday 23rd October 2023 at the Milimani Law Courts with the Director of Public Prosecutions, Mr. Renson Ingonga gracing the occasion. In his speech, he stated that, the Office of the Director of Public Prosecutions (ODPP) continues to contribute towards the national agenda by ensuring that the prosecutorial mandate is cognizant and responsive to ever changing societal dynamics. In addition, he stated that the ODPP has extensively participated in activities aimed at decongesting prisons which was done under the, All for Justice Case review banner. "I must say, that once again the ODPP has set the pace" noted Mr. Ingonga.

Other speakers at the launch included the LSK Council led by the President Mr. Eric Theuri, VP, Faith Odhiambo and other Council Members (Mr. Tom Kopere, Mr. Mwaura Kabata and Mr. Cohen Amanya) and the LSK CEO, Ms. Florence W. Muturi.

Also present for the launch were representatives from the various project partner who included; UNDP, UNODC, Amkeni Wakenya, IMLU, FIDA, CRR (Center for Reproductive Rights), ODPP, LSK Nairobi Branch and Kenya Prisons who in unison rallied on members of the public to take advantage of the week to get free legal aid from advocates who were readily available to offer the same.

The remainder of the week saw advocates offer free legal aid at various court stations and prisons where legal advice was dispensed, cases reviewed and follow ups noted. The Prisons included Langata Womens', Nairobi West, Industrial Area Nairobi Remand, Isiolo GK Prison amongst others.

There was also a free community legal aid and engagement forum held under the theme, Enhancement of Access to Justice for the poor and marginalized women in Nairobi County and Sexual Gender Based Violence at the Kamukunji Grounds in Kibera on Thursday 26th October 2023.

The Legal Awareness Week was held Countrywide across all the eight (8) Branches.





## LSK ENHANCES THE FIGHT AGAINST MASQUERADERS

The Practice Standards and Ethics Committee through its Convener Ms. Lindah Kiome received numerous reports of persons pretending to be advocates and practicing their illegal acts in the areas of Siaya, Kakamega, and Nairobi. As part of the LSK's mandate to advance ethical practice through the weeding out of masqueraders by programming periodic campaigns, and engaging stakeholders in the criminal justice system the Committee and the Director Practice Standards engaged in the exercise to weed out masqueraders. This exercise began in Siaya on 17th October 2023 and ended in Nairobi on 19th October 2023.

The LSK urges its members to join in the fight against unethical practice and at the same time Members of the public are advised against engaging the services of unqualified persons in any legal transactions.

## KENYA- UK LEGAL FORUM

The Law Society of Kenya in partnership with The Bar Council of England and Wales hosted the UK - Kenya Legal Forum on 19th October 2023 at the Villa Rosa Kempinski, Nairobi.

The forum included leading lawyers from the two Bar Associations who shared their expertise and knowledge on various topics within Law.

In attendance was the LSK Council who included the LSK President Mr. Eric Theuri, LSK VP Ms. Faith Odhiambo and Council Members Njoki Mboce, Mwaura Kabata, Byron Menezes, Lindah Kiome and Cohen Amany and LSK DCEO Mwathi Kitonga.

The Senior Bar was also represented by Mr. Philip Murgor, SC and Fred Ojiambo, SC.





## **LSK APPEARS BEFORE THE PARLIAMENTARY DEPARTMENTAL COMMITTEE ON FINANCE AND NATIONAL PLANNING**

The Law Society of Kenya appeared before the Parliamentary Departmental Committee on Finance and National Planning to share their comments on the Draft National Tax policy. The LSK was represented by Deputy Secretary, Mr. Collins H. Odhiambo who highlighted pertinent recommendations to the Committee on the Policy at the Eka Hotel.

Mr. Odhiambo submitted on the Draft National Tax policy where he observed that the policy should be able to capture the aspirations of the sovereignty of the people of Kenya and not just the aspirations of the Kenya Revenue Authority. He continued to highlight key recommendations for consideration by the Committee which included; the policy should have been guided by broad-based research touching on various aspects of the economy and the drafting process should have included carrying out of a legislative impact assessment before any laws on tax are introduced to Parliament.

In addition, and tied up with the earlier recommendation for the policy to be guided by research, he stated that there should be an aspect of monitoring and evaluation to enable clear assessment of how any new policy or legislation is affecting the economy. The Deputy Secretary also indicated that the draft policy made no reference to the constitutional underpinnings and constitutional principles that govern taxation. It was further proposed that the policy should be reviewed with a wider range of stakeholders involved and be termed as public participation.

RE: HANDLING OF PRO-BONO BRIEFS ALLOCATED UNDER THE JUDICIARY PAUPER BRIEFS AND PRO-BONO SERVICES SCHEME

We make reference to the notice dated 8<sup>th</sup> June, 2023.

There has been some good progress with respect to resolution of the grievances raised in the above-mentioned notice. We are aware that the outstanding bills have substantially been settled and we have been given an undertaking that the remaining bills will be settled soon. It is now agreed that the payment with respect to the Pro-bono briefs shall be per individual Accused Person and not per file. It is equally agreed that the payments should be done regularly and in a timely manner.

To facilitate a conducive environment for further negotiations and to safeguard the interests of the Accused Persons, we hereby call off the Boycott effective 23<sup>rd</sup> October, 2023. We shall not relent in pursuing the members' interests and ensuring that the ongoing deliberations bear better returns to us all.

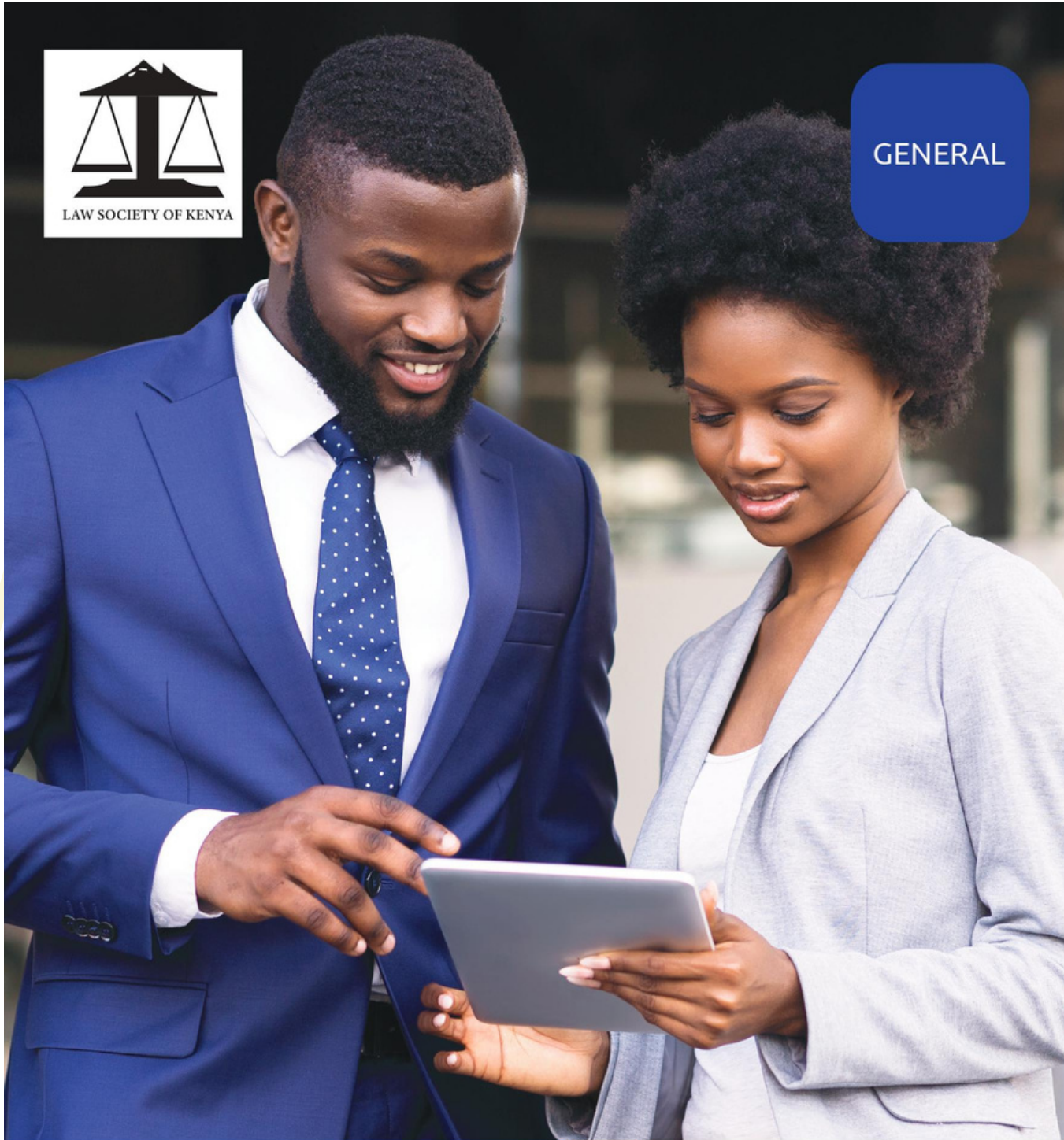

### Who is an Advocate of the High Court of Kenya?

A person duly entered to roll of Advocates and has a practicing certificate for the current year.

You can check the practice status of such an advocate on [online.lsk.or.ke](https://online.lsk.or.ke) by clicking on **Search Advocate** and entering the name of the advocate. If the Advocate has a valid practicing certificate(PC), it will be **Active**. If not, it will be **Inactive**.

*In case an advocate is practicing without a PC, please report to the director practice standards by email to [compliance@lsk.or.ke](mailto:compliance@lsk.or.ke) or send a letter to LSK Secretariat.*

*Practicing without a valid Practicing Certificate is professional misconduct tantamount to disciplinary proceedings.*
