#### 1 INTRODUCTION

The Law Society of Kenya (LSK), a professional statutory body established under the Law Society of Kenya Act, 2014, conducted the Legal Awareness Week (LAW) 2023, a transformative initiative spanning three months with a focus on promoting access to justice, legal education, and addressing prison congestion. This comprehensive approach aligns with LSK's mission to advance the rule of law, uphold the Constitution of Kenya, and promote the rights of imprisoned persons and the underprivileged public. The initiative also seeks to engage both state and non-state actors in criminal justice reforms. The event was executed in two phases, with Phase 1 taking place from October 1st to October 31st, 2023.

#### 2 BACKGROUND



In the pursuit of its mission, LSK has consistently observed the growing number of cases brought before the Kenyan courts and the subsequent rise in the number of individuals imprisoned for minor crimes. The

challenges posed by the overcrowding of correctional facilities in Kenya, combined with the need to protect the rights of incarcerated individuals and the underprivileged public, have compelled LSK to embark on a crucial mission to facilitate Criminal Justice Reforms. These reforms aim to address the rights of prisoners and, in turn, potentially decongest the nation's prisons.

In 2023, the Law Society of Kenya adopted a proactive and transformative approach to realize its objectives by organizing an annual Legal Aid Awareness week, which was executed under the theme: "Unlocking Justice: A Collective Effort to Decongest Prisons and Deliver Legal Aid." The initiative aimed to address prison overcrowding, promote





legal awareness, and engage both state and non-state actors in the broader criminal justice reform agenda.

Recognizing the significance of the issue at hand, LSK structured the Legal Awareness Week to span a period of three months while retaining the traditional Legal Awareness Week (LAW) from 23rd to 27th October 2023. This approach allowed for a more comprehensive and sustained effort to tackle the multifaceted problems associated with prison congestion. Throughout the initiative, LSK collaborated closely with various key state and non-state actors involved in legal aid and prison reforms.

Phase 1 of the Legal Awareness Week encompassed a series of activities aimed at creating awareness, providing legal aid, and conducting interventions to address the issue of prison congestion. These activities included the Correctional Reforms Stakeholders' breakfast meeting, the observance of LAW, logistical mobilization for Phase 2 capacity-building sessions, and legal aid clinics for the public and persons deprived of their liberty in prisons. The first phase of the initiative targeted five strategically chosen counties to maximize its impact.



In Phase 2, LSK is set to further enhance the capacity of advocates to provide legal aid and will focus on the training of advocates, stakeholder mobilization, the development of a

Position Paper, and

the identification of cases suitable for diversion and plea bargaining. This phase aims to significantly contribute to the decongestion of correctional facilities and promote alternative approaches to incarceration.

As the Legal Awareness Week 2023 transitions from Phase 1 to Phase 2, it seeks to address the pressing issues associated with prison overcrowding and make justice more accessible to all Kenyan citizens, irrespective of their geographical location or financial

resources. This initiative underscores the pivotal role of the legal profession in upholding the rule of law and ensuring justice for all individuals in the nation.

#### 3 RATIONALE

The Legal Awareness Week 2023 aimed to address the issue of prison overcrowding and promote legal awareness among the general population. Overcrowding in Kenyan prisons can lead to human rights violations, increased violence, and limited access to rehabilitation and reintegration programs. By conducting this initiative, LSK sought to:

- Promote legal education to the public on their legal rights and responsibilities, emphasizing the consequences of criminal activities and the importance of adhering to the law.
- 2. Raise awareness about prison conditions, highlighting the challenges faced by inmates in overcrowded prisons, such as limited access to healthcare, education, and rehabilitation programs.
- 3. Provide free legal aid during the awareness week to help individuals navigate the legal system and potentially reduce the number of people going through the prison system.
- 4. Promote alternative sentencing options, including plea bargaining, diversion, community service, restorative justice, probation, and diversion programs.
- 5. Engage in stakeholder collaborations with government agencies, civil society organizations (CSOs), and legal professionals to gather data, technical expertise, resources, and operational support.
- 6. Encourage pre-trial reforms, such as bail reform and speedy trials, to prevent individuals from spending prolonged periods in prison remand before their cases are resolved.

#### 5 WHAT NEXT?

#### 5.1 PHASE 2: November 1st - December 31st

In light of the successful implementation of Phase 1, LSK is now prepared to move forward with Phase 2. This phase will focus on:

- 1. Training 200 Advocates drawn from 32 counties on plea bargaining, diversion, pre-trial detention/trial advocacy, and the Small Claims Court.
- 2. Stakeholder mobilization to support LSK's initiative toward decongesting prisons.
- 3. Development of a Position Paper by an LSK consultant, focused on the congestion in Kenyan prisons, and its dissemination to multi-pronged advocacy groups to impact correctional facility decongestion.
- 4. Advocating for the decongestion of prisons through the identification of cases suitable for diversion and plea bargaining, in collaboration with ODPP and the judiciary.

The combined impact of both phases will result in improved access to justice for all, making justice more accessible to a wider spectrum of Kenyan citizens and fostering a stronger commitment to upholding the rule of law.

#### 6 THE CORRECTIONAL REFORMS STAKEHOLDERS BREAKFAST MEETING



As the inaugural activity of the Legal Awareness Week (LAW) 2023, the Law Society of Kenya (LSK) convened a pivotal Correctional Reforms Stakeholders Breakfast Meeting (CRSB-Meeting). This high-level consultative gathering was held on Wednesday, 18th October 2023, from

8:00 am to 11:00 am. The meeting served as a platform for meaningful discourse and collaboration among a diverse array of stakeholders, including key state and non-state partners dedicated to justice and prison reforms.

#### 6.2 Objectives of the CRSB-Meeting

The Correctional Reforms Stakeholders Breakfast Meeting was organized under the auspices of the National Council on the Administration of Justice (NCAJ)

The meeting was guided by a concise yet comprehensive objectives which included:

- i. Mobilization of Participation in the Legal Awareness Week (LAW) 2023: This segment aimed to mobilize the active involvement of all participants in the forthcoming LAW 2023 activities, ensuring a collective and concerted effort.
- ii. **Expounding on the Theme of the Project:** The meeting provided a platform to delve deeper into the central theme of the LAW 2023, "Unlocking Justice: A Collective Effort to Decongest Prisons and Deliver Legal Aid." Stakeholders had the opportunity to elucidate their perspectives, insights, and contributions in line with this overarching theme.
- iii. Collating Efforts Towards Legal Aid and Case Review Interventions: This crucial aspect of the meeting focused on the collaborative efforts and strategies for legal aid provisions and case review interventions. Stakeholders were encouraged to share their knowledge, experiences, and proposed actions in this realm.

The Correctional Reforms Stakeholders Breakfast Meeting served as a cornerstone for the LAW 2023 initiative, fostering cooperation and coordination among diverse actors, both state and non-state, who are committed to effecting positive change in the Kenyan





criminal justice system. This strategic gathering laid the foundation for a collective effort to address the challenges of prison congestion and to make justice more accessible for all Kenyan citizens. The insights and commitments emanating from this meeting paved the way for the successful execution of the subsequent phases of the LAW 2023 initiative.

6.3 Introduction and Welcome Address: Significance of the Correctional Reforms. Speaker: Ms. Florence Muturi, Chief Executive Officer of the Law Society of Kenya



Ms. Florence Muturi, the Chief Executive Officer of the Law Society of Kenya (LSK), commenced the Correctional Reforms Stakeholders Breakfast Meeting by delivering the Welcome Address and introducing the event, setting the stage for the significant gathering.

Ms. Muturi initiated the proceedings by

acknowledging Advocate Njeri Mutitu, who led the assembly in a prayer, emphasizing the importance of faith and goodwill in our collective efforts.

In the spirit of unity, Ms. Muturi requested that all participants stand for both the national anthem and the East African anthem, symbolizing the shared identity that binds us in our mission.

Furthermore, Ms. Muturi explained the two main phases of the LAW 2023 initiative, Phase 1 and Phase 2, and highlighted the reason for the three-month extension of the

initiative. She emphasized the urgency of the matter and the need for a comprehensive approach.

In the context-setting phase of her address, Ms. Muturi stressed the significance of convening the initial stakeholder meeting before diving into the



implementation of the scheduled activities. She underscored the importance of shared understanding, collaborative strategies, and the valuable input of all participants in shaping the direction of the initiative.

Ms. Muturi concluded her address by urging all participants to actively engage in the meeting, share their perspectives, insights, and experiences, and work together towards the common goal of unlocking justice and reforming the correctional system.

6.4 Opening Remarks: Importance of Collaboration in Unlocking Justice

Speaker: Mr. Mwaura Kabata, PIL Convener and Council Member LSK

Mr. Mwaura Kabata, in his capacity as a key speaker, delivered the Opening Remarks, shedding light on the paramount importance of collaboration in the pursuit of unlocking justice. His speech emphasized the power of collective efforts and shared dedication to the cause.

During his address, Mr. Kabata underscored the



significance of collaboration in addressing the challenges posed by prison overcrowding

The President's address provided additional insights and perspectives on the mission of the LSK and the importance of the Correctional Reforms Stakeholders Breakfast Meeting.

These introductory remarks and speeches set the stage for the substantive discussions and activities that would follow, emphasizing the collaborative and unified approach to the correctional reforms and the achievement of accessible justice for all.

6.5 Remarks by the Development Partner Speaker: Mr. Jaffar Mohamed, Advocate representing the UNDP





Mr. Jaffar Mohammed, representing the United Nations Development Programme (UNDP), our esteemed project sponsor, joined the Correctional Reforms Stakeholders Breakfast Meeting through a virtual speech. His virtual presence served as a testament to the commitment of the UNDP to the LAW 2023 initiative and the overarching goal of unlocking justice.

In his remarks, Mr. Mohammed expressed the UNDP's dedication to supporting initiatives that promote justice, human rights, and the rule of law. He highlighted the significance of the LAW 2023 initiative in addressing the critical issue of prison congestion and enhancing access to justice for all Kenyan citizens.

Mr. Mohammed's speech underlined the pivotal role of development partners in facilitating positive change and progress. He commended the collaborative efforts of all stakeholders involved in the initiative, emphasizing the importance of unity in achieving the desired outcomes.

Furthermore, Mr. Mohammed reiterated the UNDP's commitment to working hand in hand with the Law Society of Kenya and other stakeholders to effect meaningful change in the correctional system. He recognized the challenges posed by prison overcrowding and affirmed the UNDP's support for innovative approaches aimed at decongesting prisons and delivering legal aid.

His virtual speech served as a source of inspiration and motivation for all participants, reaffirming the shared commitment to unlocking justice and promoting correctional reforms in Kenya.

#### 6.6 Insights from the Stakeholders: Goal Setting

6.6.1 Remarks by Mr. Samson Davies Maundu-Principal Parliamentary Counsel, Office of the Attorney-General & Department of Justice

Mr. Samson Davies Maundu, Principal Parliamentary Counsel representing the Office of the Attorney-General and Department of Justice, delivered a significant address during the Correctional Reforms Stakeholders Breakfast Meeting. In his remarks, he highlighted crucial points related to the holistic approach required to address prison congestion and promote long-term solutions in the Kenyan criminal justice system.





Mr. Maundu serves as the Hon. Attorney-General's representative on the National Council on the Administration of Justice (NCAJ) Committee on Criminal Justice Reforms, providing valuable insights into ongoing efforts to amend various laws related to the criminal justice system, including the Penal Code, Criminal Procedure Code, Prisons Act, and the Borstal Institutions Act.

#### Key points from Mr. Maundu's address included:

- 1. The Need for Comprehensive Policy Proposals: Mr. Maundu emphasized that to effectively address prison congestion, stakeholders should consider making comprehensive policy proposals to the Hon. Attorney-General and the Cabinet Secretary for the Interior. These proposals should cover the treatment of suspected offenders from the point of accusation to their discharge by the criminal justice system.
- 2. Development of Reporting Tools: Mr. Maundu recommended that, during the implementation of the program outlined in the Concept Note, the Law Society of Kenya (LSK) and its partners should develop reporting tools. These tools would aid in identifying key policy issues that need to be addressed for comprehensive decongestion efforts. He particularly highlighted the importance of considering the role of the Probation and After Care Department and the use of Parole (under section 49 of the Prisons Act). Additionally, he stressed the importance of extensively using diversion and plea bargaining for non-violent minor offenses such as traffic violations, common assault, and misdemeanors.
- 3. Comprehensive Review of the Criminal Justice Legal Framework: Mr. Maundu proposed that the Kenya Law Reform Commission should undertake a comprehensive review of the criminal justice legal framework. The objective of this review would be to recommend a complete overhaul of the existing system. He suggested that a well-designed and well-resourced reform program could be finalized within two to four years and should be prioritized by all criminal justice sector actors, including the LSK.

Mr. Maundu's remarks underscored the need for a comprehensive and coordinated approach to address prison congestion in Kenya's criminal justice system. His insights





provided valuable guidance for future actions and policy initiatives aimed at achieving long-term solutions.

# 6.6.2 Remarks By Jacqueline Njagi-Prosecutor, Office of the Director of Public Prosecutions (ODPP)



During the Correctional Reforms Stakeholders Breakfast Meeting, Jacqueline Njagi, a prosecutor at the Office of the Director of Public Prosecutions (ODPP). delivered remarks the successes on and challenges of a similar project known as the 'All for Justice Project.' Her

insights provided valuable context for the ongoing initiatives and demonstrated the ODPP's commitment to addressing critical issues within the Kenyan criminal justice system.

Jacqueline Njagi highlighted key points from the 'All for Justice Project,' drawing attention to the project's objectives and accomplishments. She referenced the recent launch of the Malalamishi System, a digital platform introduced by the ODPP to allow Kenyans to lodge complaints and request case reviews online. The platform not only streamlines the complaint process but also enables anonymous reporting, thus providing room for whistleblowers to come forward.

One significant aspect of the Malalamishi System is the case review module, which allows members of the public to request a review of their cases by the ODPP. Each request is assigned a reference number to facilitate tracking of progress, making it easier for complainants to follow up on their cases.

The 'All for Justice Project,' initiated in 2018 as part of its Phase I, focused on addressing the delay in the disposal of criminal cases, which had led to prison overcrowding. Notably, Phase I yielded impactful results, including the expedited handling of cases, a reduction in case backlog, and a decrease in the percentage of remandees within the prison population. These successes underscore the importance of collaborative efforts in enhancing the efficiency of the criminal justice system.





Director of Public Prosecutions Noordin Haji emphasized the significance of the project's second phase, which aims to make the prosecution service more responsive to the needs of the mwananchi (citizen). The project intends to provide a second chance for remandees to reform and be reintegrated into society. Furthermore, by implementing plea bargaining and diversion policies, the project is expected to save resources that would have been expended if cases went to full trial, thus benefiting both individuals and the government.

Jacqueline Njagi remarks shed light on the ODPP's commitment to criminal justice reform and its ongoing efforts to reduce prison congestion and case backlog in the country. Her insights provided a valuable perspective on the challenges and successes of similar initiatives, offering guidance and inspiration to stakeholders at the breakfast meeting.

6.6.3 Remarks by Dixon Mwakazi- Senior Assistant Commissioner Director General Legal, Human Rights Research and Statistics Prison HQ Nairobi- Kenya Prison Service

During the Correctional Reforms Stakeholders Breakfast Meeting, Mr. Dixon Mwakazi, the Regional Commander of the Kenya Prison Service, delivered a significant address highlighting the key role played by the Kenya Prison Service in the ongoing initiatives to address prison congestion and improve the country's criminal justice system.

Mr. Mwakazi commenced his remarks by acknowledging the presence of distinguished stakeholders from various sectors and expressing his gratitude for the opportunity to participate in this vital meeting. He emphasized the importance of collaboration among all stakeholders involved in the criminal justice sector, recognizing that collective efforts are essential to effect lasting change.



As the Regional Commander of the Kenya Prison Service, Mr. Mwakazi provided valuable insights into the challenges faced within the correctional system. He stressed





the critical need for innovative and comprehensive solutions to address the issue of prison overcrowding and enhance the conditions of inmates. He also emphasized the importance of providing opportunities for the rehabilitation and reintegration of inmates into society.

Mr. Mwakazi shared the Kenya Prison Service's commitment to working closely with other justice sector actors to implement effective strategies for decongesting prisons. He highlighted the significance of collaboration and coordination between the Kenya Prison



Service, the Office of the Director of Public Prosecutions (ODPP), the Judiciary, and other relevant agencies to achieve these goals.

Furthermore, Mr. Mwakazi expressed the Kenya Prison Service's dedication to ensuring that correctional facilities adhere to international standards and best practices. He discussed the initiatives and programs aimed at enhancing the well-being of inmates, emphasizing the importance of respect for human rights and the dignity of all individuals within the prison system.

In conclusion, Mr. Mwakazi reiterated the Kenya Prison Service's commitment to actively participating in the initiatives presented at the breakfast meeting and its readiness to work in partnership with all stakeholders to achieve the common goal of prison decongestion and criminal justice reform.

Mr. Mwakazi's remarks provided a vital perspective from the Kenya Prison Service and underscored the importance of collaborative efforts to address the challenges faced by the correctional system.

#### 6.7 CONCLUSION AND WAY FORWARD

The Correctional Reforms Stakeholders Breakfast Meeting, held under the guidance of Miss Mwathi Kitonga, led to a comprehensive discussion on the critical issues surrounding prison congestion and the broader reform of the criminal justice system in

Kenya. The session on Key Takeaways highlighted the significant conclusions and the proposed way forward, summarizing the insightful discussions and key recommendations provided by the stakeholders.

#### 6.7.1 Key Recommendations from Stakeholders:

- 1. Collaborative Commitment: One of the pivotal takeaways from the meeting was the resounding importance of collaborative commitment. The meeting brought together a diverse group of stakeholders, including the ODPP, NLAS, NPS, Judiciary, Office of the Attorney General, Kenya Prison Service, CAJ, Probation and Aftercare Services, KNCHR, and more, all of whom expressed their unwavering commitment to work together in addressing prison overcrowding.
- 2. Legal Awareness Week (L.A.W) 2023: The meeting reinforced the significance of L.A.W 2023 as a platform for promoting awareness of legal rights and responsibilities among the public. The theme, "Unlocking Justice: A Collective Effort to Decongest Prisons and Deliver Legal Aid," received widespread endorsement, highlighting its relevance and importance.
- 3. Alternative Sentencing: Stakeholders recognized the critical role of alternative sentencing methods in reducing the number of non-violent offenders entering prisons. Methods such as plea bargaining, diversion, community service, restorative justice, and probation were discussed as effective means to address this issue.
- 4. Legal Aid and Access to Justice: The meeting emphasized the need for increased legal aid services, providing free legal consultations and assistance to individuals





to navigate the legal system. By doing so, it is anticipated that this would reduce the number of individuals entering the prison system.

5. Advocacy for Pre-trial Reforms: Stakeholders highlighted the vital importance of advocacy efforts aimed at improving pre-trial detention procedures. These efforts include bail reform and speedy trials, intended to prevent prolonged periods of remand in prisons before cases are resolved.

#### 6.7.2 Way Forward:

To build on these critical conclusions and recommendations, the stakeholders collectively charted the way forward:

 Collaborative Efforts: Continued collaboration and coordination among all stakeholders, including government agencies, civil society organizations, and legal professionals, were



underscored as being essential in the ongoing efforts to decongest prisons. A united front of stakeholders working together is seen as key to success.

- ii. **Community Sensitization:** Recognizing the significance of community engagement, the stakeholders concurred with the recommendation of conducting community sensitization forums, a strategy backed by UNDP and other partners. These forums are expected to raise awareness and educate the public on legal matters.
- iii. Implementation of Strategies: To ensure the effectiveness of the proposed solutions, it was emphasized that a clear plan and strategy must be developed.
  This should include defining actionable steps and setting deadlines to adhere to.
- iv. **Monitoring and Evaluation:** Regular monitoring and evaluation mechanisms will be established to track progress, identify challenges, and adapt strategies as needed. Continuous assessment is integral to achieving the intended goals.
- v. Advocacy and Awareness: The meeting concluded with a commitment to a robust advocacy and awareness campaign. This campaign extends beyond L.A.W





2023 and aims to engage the broader community and maintain the momentum generated by the stakeholders' shared dedication.

In summary, the Correctional Reforms Stakeholders Breakfast Meeting served as a significant platform for a diverse array of stakeholders to come together, share their insights, and collaboratively address the complex issues of prison congestion and criminal justice reform. The conclusions drawn and the proposed way forward reflect the commitment of all stakeholders towards achieving these critical goals.

## 7 THE LAUNCH OF THE LEGAL AWARENESS WEEK

The grand inauguration of the traditional LSK Legal Aid Week 2023 was а momentous event held at the iconic Milimani Law Courts on October 23, 2023. The event witnessed participation from a distinguished array of including speakers, the esteemed members of the LSK Council led by President Mr.



Eric Theuri, Vice President Faith Odhiambo, and Council Members Mr. Tom Kopere, Mr. Mwaura Kabata, and Mr. Cohen Amanya. Additionally, the LSK CEO, Ms. Florence W. Muturi, graced the occasion with her presence.



The event also garnered significant support from various project partners, comprising UNDP, UNODC, Amkeni Wakenya, KRA, Amnesty International, IMLU, FIDA, CRR, ODPP, LSK Nairobi Branch, and Kenya Prisons and others. These esteemed partners united in a

resounding call to the public, urging them to seize the opportunity presented by Legal Aid Week to access free legal assistance from readily available advocates.





The Official Launch of Legal Awareness Week on October 23, 2023, at Milimani Law Courts, was a remarkable occasion attended by Mr. Renson Ingonga, the Director of Public Prosecutions. In his address, Mr. Ingonga emphasized that the Office of the Director of Public



Prosecutions (ODPP) remains steadfast in its commitment to the national agenda by ensuring that the prosecutorial mandate remains adaptive and responsive to everevolving societal dynamics. He also highlighted the extensive participation of the ODPP



in endeavors aimed at decongesting prisons, a mission conducted under the "All for Justice Case Review" banner. Mr. Ingonga commended the ODPP for its pioneering role in this effort, noting that they have once again set the pace for others to follow.

The launch was marked by the presence of both advocates and various legal aid clients, some of whom were affiliated with the various Justice Centers. After the formal launch of the event, advocates promptly attended to the clients, offering them valuable legal assistance. As part of the symbolic launch, two clients were assigned, one to the Director of Public Prosecutions and the other to the President of the Law Society of Kenya. Following the successful provision of legal aid to these clients, both dignitaries committed to overseeing the follow-up on their respective cases.

Amid these successful proceedings, the much-anticipated L.A.W 2023 was officially declared open, signifying the commencement of a week dedicated to the provision of essential legal services to the public.

The launch event included the following highlights:







- i. Legal Aid Client Assistance: Advocates were readily available to provide legal aid to clients attending the event.
- Partnership Showcase: Civil society organizations and state and non-state institutions partnering with LSK were allocated booths within the court premises. These booths served as stations for offering legal aid to the public.
- iii. Symbolic Legal Aid Provision: To mark the official opening of L.A.W 2023, two clients were allocated to the Director of the Public Prosecutions and the President of the Law Society of Kenya. Both committed to ensuring the follow-up on their respective cases.

In this resounding launch, the legal community, partners, and clients converged with the shared commitment to uphold justice, provide legal aid, and address the legal needs of the public during the LSK Legal Aid Week 2023. The following are the proceedings of the event:

#### 7.1 The Proceedings of the Launch Day.

7.1.1 Welcoming Remarks- Ms. Florence Muturi, Secretary/Chief Executive Officer LSK

In her welcoming remarks, Ms. Florence Muturi, Secretary/Chief Executive Officer of LSK, set a vibrant tone for the meeting by establishing the protocol for the day, extending a warm welcome to all attendees, leading the rendition of the national anthem and opening prayer, and providing a clear overview of the day's agenda and its context.







#### 7.1.2 Welcoming Remarks -Ms. Helene Namisi Chairperson-LSK Nairobi Branch

## 7.2.1 United Nations Development Programme: Mr. Mohamed Jaafar -Programs Manager

#### 7.2.2 Independent Medico Legal Unit : Isabella Obara TL-Legal Unit

She began her speech by

Isabella noted the critical issue of prison congestion and the pressing need for access to justice.

The Legal Awareness Week, spanning from 23rd to 27th October 2023 and continuing over the next three months, is designed to confront these challenges head-on. Collaborative partners aim not only to raise awareness about the plight of inmates in overcrowded prisons but also to provide tangible medico-legal aid and explore alternative sentencing options. Their collective mission is to promote legal literacy and facilitate access to justice throughout the country. They also recognize the importance of sensitizing both advocates and the public on the workings of the Small Claims Court, contributing to a more efficient and responsive legal system.





Isabella Obara concluded her speech by emphasizing that justice is not an abstract concept but a living reality that must touch the lives of every citizen. She stressed the importance of collective commitment to unlocking justice, ensuring that it becomes a fundamental right accessible to all. Isabella called for unity and cooperation in this journey of legal empowerment, equality, and justice for all.

Her speech underlined the significance of the Legal Awareness Week in promoting justice, legal aid, and human rights, and highlighted the urgent need for collaboration and collective action to address the challenges in Kenya's legal system and correctional institutions.

### 7.2.3 Center For Reproductive Rights -Edigah Mugamangi, Senior Manger Pro Bono Africa



Edigah Mugamangi, Senior Manager for Pro Bono in Africa at the Center for Reproductive Rights, delivered an impactful speech during the opening of the Law Society of Kenya's Annual Legal Awareness Week. His speech highlighted the importance of collaboration and the shared commitment to advancing reproductive health rights in Kenya.

Edigah began his speech by expressing immense gratitude and a profound sense of responsibility. He introduced himself and provided insight into the Center for

These challenges include high maternal mortality rates, inadequate family planning services, and societal stigmas surrounding reproductive health.





However, Edigah noted that hope exists in the power of collaboration. The partnership between the Center for Reproductive Rights and the Law Society of Kenya exemplifies the potential for positive change. This collaboration is rooted in the shared belief that individuals have the right to make decisions about their own bodies and reproductive health, free from discrimination, coercion, or violence.

Edigah shared that their initiatives aimed at advancing reproductive rights and expanding pro bono legal services have demonstrated the transformative impact of this partnership. Legal expertise, combined with their mission, has the potential to change lives and break down legal barriers restricting access to reproductive healthcare.

He underscored the critical role of the legal community in advocating for change and eliminating barriers to reproductive healthcare. The partnership between the Center for Reproductive Rights and the Law Society of Kenya is a testament to the power of collaboration in this regard.

Edigah expressed heartfelt gratitude to the Law Society of Kenya for their unwavering support, dedication, and partnership in advancing reproductive rights. He acknowledged their instrumental role in the progress achieved and expressed a commitment to building upon this foundation of collaboration. Together, they are determined to continue their collective efforts to safeguard and advance reproductive rights and deepen the pro bono culture in Kenya.

Edigah's speech highlighted the critical work being done to address reproductive health rights and emphasized the essential role of collaboration and partnership in driving positive change in Kenya.

#### 7.2.4 Federation of Women Lawyers) – Kenya-Executive Director Ms. Anne Ireri

Anne Ireri, the Executive Director of the Federation of Women Lawyers - Kenya (FIDA-Kenya), shared key insights during her address at the event. (LSK) to provide legal aid to the residents of Kibera, an informal settlement in Nairobi. This outreach program is a vital step toward ensuring that legal services are accessible to marginalized communities.

Another significant aspect of Anne's speech was FIDA-Kenya's campaign to combat domestic violence. Domestic violence remains a pressing issue, and FIDA-Kenya's efforts in this regard reflect their dedication to addressing and eradicating this problem.

Furthermore, Anne acknowledged the commendable work done by the Law Society of Kenya during the Annual Legal Awareness Week. She expressed FIDA-Kenya's support for LSK's initiatives in raising legal awareness and facilitating access to justice. This collaboration between the two organizations is instrumental in advancing the cause of justice and legal rights.

Anne's address served to emphasize the importance of collective efforts in promoting legal awareness, access to justice, and the protection of vulnerable individuals. FIDA-Kenya's involvement in various campaigns and initiatives underscores their commitment to addressing pressing issues and supporting LSK's vital work during the Annual Legal Awareness Week.

#### 7.3 Speeches by Special Guests

#### 7.3.1 Vice President - Law Society of Kenya Ms. Faith Odhiambo



Faith Odhiambo, the Vice President of LSK, welcomed the esteemed guests, including Mr. Renson Director Public Mulele, of Prosecutions (DPP), and various representatives from partner organizations, underscoring the importance of the event. She painted a vivid picture of prison

overcrowding and emphasized the need for a collective response.







**Overcrowded Prisons:** Faith pointed out the grave situation of overcrowded prisons. Despite constitutional provisions and laws that support non-custodial sentences and bail rights, the prisons are bursting at the seams.

**Collective Responsibility:** She called for collaboration between the National Council on the Administration of Justice, the Judiciary, ODPP, KPAS, WPA, NGOs, and all justice sector participants. Faith stressed the necessity of cooperation to alleviate this challenge, noting that any lapse in the system poses risks.

Advocates' Oath and Pro Bono Service: Faith reminded fellow advocates of their oath to uphold justice and encouraged them to embrace pro bono work, taking on at least one more case. She acknowledged the crucial role of lawyers in providing access to justice for the poor and vulnerable.

The Judiciary Fund: She emphasized the significance of the Judiciary fund, highlighting that justice delayed due to delayed payments for pro bono cases ultimately denies justice. Prompt payments and respect for advocates' dedication are vital.

**Improving the Judicial System:** While acknowledging the Judiciary's progress in enhancing its case management system, Faith challenged them to aspire to even greater efficiency, clarity, and transparency, considering these as fundamental elements for a robust judicial system.

**Probation and Community Service:** Faith proposed the use of probation and community service as essential tools to decongest prisons. She questioned the wisdom of incarcerating individuals for minor offenses when they could positively contribute to society and undergo rehabilitation.

A Vision of Restorative Justice: Concluding with a visionary note, Faith expressed the hope for reformed prisons that focus on restorative justice, envisioning them as community centers of restoration. She acknowledged that though it may seem distant, such a vision is worth pursuing.

Faith called upon everyone to collectively remove one brick at a time from the walls built with injustice and indifference in our current prisons. She urged her fellow advocates to unite and be inspired by their solemn oath. She concluded by inviting all





attendees to make a significant difference during the Legal Awareness Week, united by their shared commitment to justice.

#### 7.3.2 President of the Law Society of Kenya -Mr. Erick Theuri

In his address, Mr. Erick Theuri, the President of the Law Society of Kenya, expressed his sincere appreciation to the advocates who generously volunteered to provide free legal aid during the event. He extended his gratitude to the Office of the Director of Public Prosecutions (ODPP) for their invaluable support and to the Judiciary and the National Council on the Administration of



Justice (NCAJ) for their substantial roles in addressing justice system challenges.

Furthermore, President Theuri took a moment to recognize and express his heartfelt appreciation to the event's sponsors for their vital contributions to the success of the Legal Awareness Week. Finally, he passionately encouraged his fellow advocates to actively participate in the week's activities by offering free legal services to the community. #### 7.3.3 Chief Guest- Mr. Renson Mulele Director of Public Prosecutions (DPP)



Mr. Renson M. Ingonga, Director of Public Prosecutions, delivered a speech at the launch of the LSK Service Week 2023, held at Milimani Law Courts in Nairobi on October 23, 2023. He commended the event's theme, "Unlocking Justice: A collaborative effort to decongest prisons and deliver legal aid," emphasizing its timeliness in advancing access to justice for all. Despite the Legal Aid Act of 2016, legal representation remains elusive for many rural Kenyans, highlighting the need to audit the Criminal Justice System's responsiveness.

Mr. Ingonga acknowledged the National Legal Aid Scheme's efforts to champion access to justice, despite recent audits revealing systemic biases against the poor in the criminal justice system. He stressed the significance of the LSK Service Week in addressing these challenges, asserting that a 21st Century prosecutor's role extends beyond case processing to analyzing societal issues and implementing crime prevention solutions.

The Director of Public Prosecutions highlighted the Office of the Director of Public Prosecutions (ODPP)'s active participation in initiatives to decongest prisons, citing the "All for Justice Case Review" as an instrumental effort that improved transparency, accountability, and efficiency. He discussed the ODPP's commitment to enhancing access to justice through continuous reviews of ongoing criminal cases, aligning with the ODPP's strategic agenda.

Mr. Ingonga proposed that the LSK Service Week's prison decongestion activity becomes an annual program within the criminal justice sector, an idea welcomed by the audience. He officially declared the LSK Service Week "Unlocking Justice" open, expressing gratitude for collective efforts and looking forward to enhancing access to justice.





#### 7.3.4 Closing Remarks – Tom Kopere , LSK Council Member

Mr. Tom Kopere, a Council Member of the Law Society of Kenya, delivered the closing remarks for the event. Following his closing remarks, the station remained active throughout the day, with advocates providing essential legal aid services to clients in need.

### 8 THE TRADITIONAL LEGAL AWARENESS WEEK

As indicated earlier in our introduction to the report, LSK conducted a series of activities aimed at promoting access to justice and addressing legal system challenges. The events spanned various locations and included diverse initiatives.

One of the central components of the week was the Court-Stationed Legal Aid Clinics. From October 23 to October 27, 2023, these clinics were operational at various venues in different LSK branches. They provided free legal aid services to the community, ensuring that individuals had access to legal assistance.

Simultaneously, prison visits were conducted in several branches during the same period. The visits targeted different correctional facilities, including remand prisons and women's prisons, with the aim of addressing the conditions of those held in custody.

Additionally, community sensitization efforts were carried out at Kibera Kamukunji Grounds on October 26, 2023. These initiatives aimed to engage and inform the community on legal matters and the importance of access to justice.







# 9 COURT -STATIONED LEGAL AID CLINICS

# 9.1 Nairobi Branch: Milimani Law Courts, Kibera Law Courts, Makadara Law Courts

The Nairobi Branch of the Law Society of Kenya (LSK) collaborated seamlessly with the National Office to implement a series of legal aid clinics during the Legal Awareness Week 2023. The clinics were strategically stationed at Milimani Law Courts, Kibera Law Courts, and Makadara Law Courts, with Milimani Law Courts hosting the flagship event that garnered the highest turnout.

#### Milimani Law Courts Legal Aid Clinic:

#### Narration:

Milimani Law Courts emerged as the epicenter of the Nairobi Branch's engagement during the Legal Awareness Week. The collaborative efforts of the branch and the National Office created a well-coordinated and impactful event that drew the attention of a substantial number of advocates and clients.

The legal aid clinic at Milimani Law Courts witnessed an exceptional turnout of both advocates and clients. The collaborative effort between the Law Society of Kenya (LSK) and the Federation of Women Lawyers (FIDA) culminated in a community sensitization event the Kibera at Kamukunji Grounds. This open-air gathering featured of activities an array

designed to engage the community, raise legal awareness, and provide valuable legal





aid services. The presence of Mr. Amocha Nehemiah, the local Chief, added significance to the event as he addressed the assembled crowd, emphasizing its importance.

The event boasted dedicated facilitators who conducted informative sessions, focusing on the central theme of the Legal Awareness Week: "Enhancement of Access to Justice for Poor and Marginalized Women in Nairobi County." In addition to this, the critical topic of "Sexual Gender-Based Violence" took center stage in discussions. The primary objective was to sensitize the community regarding gender-based violence and enhance access to justice for impoverished and marginalized women within Nairobi County.

The remaining cases were brought back to the LSK for categorization, reassignment to the appropriate Bars to Justice partners, and ongoing follow-ups.

In summary, this one-day open-air event exemplified the fruitful collaboration between the LSK and FIDA in creating legal awareness, enhancing access to justice, and addressing critical issues like gender-based violence within the Nairobi County community. The active participation of multiple stakeholders, including community members, legal advocates, and esteemed organizations, further reinforced the event's success and impact.

This clause focuses on the Awareness March through Eldoret Town and the Community Sensitization activities.

Activity Overview:

The central focus of the discussions was "Enhancement of Access to Justice for poor and marginalized women in Nairobi County" and the crucial subject of "Sexual Gender-Based Violence." The Awareness March through Eldoret Town and the Community Sensitization activities during the Legal Awareness Week were highly successful in promoting legal education and community engagement. These activities not only raised legal awareness





but also provided essential support to the local community. We commend the participants and stakeholders for their dedication and support, and we look forward to implementing the provided recommendations to enhance future Legal Awareness Week event.

We extend our appreciation to all participants, sponsors, and the local community members who participated in the Awareness March and Community Sensitization activities. Their enthusiasm and support significantly contributed to the success of this event.

# 11.3 Overall Recommendations-Future Community Sensitizations

Based on the substantial turnout and the impact witnessed during the recent community sensitization event, it is strongly recommended that the Law Society of Kenya (LSK) expand its outreach efforts in the upcoming Legal Awareness Week (LAW). The success of reaching a wider audience and effectively addressing legal issues is a testament to the efficacy of taking legal aid directly to the community, especially at the grassroots level.

The experience highlights the importance of proactive community engagement, where LSK brings its services directly to the clients who may not have easy access to legal assistance. By reaching out to the community, LSK can make a more significant impact on addressing legal concerns and providing access to justice for those who need it the most. This proactive approach ensures that legal aid services are accessible, practical, and relevant to the communities they serve.

Expanding community sensitization stations across the country can lead to a more profound and far-reaching impact, especially in areas where legal aid services are often limited or non-existent. By making legal aid services more accessible, LSK can play a crucial role in empowering marginalized communities and ensuring that they are aware of their legal rights and avenues for seeking justice.





In summary, the success of the recent community sensitization event underscores the importance of taking legal aid directly to the community. The recommendation is for LSK to continue and expand such efforts in future Legal Awareness Weeks, contributing to a more inclusive and effective justice system that truly serves all members of society.

# 12 REPORT ON ADVOCATES DISCIPLINARY TRIBUNAL DESK DURING LEGAL AWARENESS WEEK 2023

The primary objective of the Advocates Disciplinary Tribunal (ADT) desk was to raise

awareness about the existence of the Disciplinary Tribunal among the public and guide them on the process of complaints filing against advocates. Additionally, the desk aimed to receive and assist individuals who had complaints against advocates but were unsure of the appropriate procedures.



**Communication:** The awareness of the ADT desk was disseminated through the LSK/Newsletter, reaching advocates via email. In addition, 250 fliers and banners titled "Know Your Tribunal" were published and distributed at all High Court stations where the Legal Awareness Week events were held.

**Target:** The target audience for the ADT desk was the general public, with a focus on individuals who might have grievances against advocates.

Information/Data Collection: Help forms were made available at the Milimani High Court station, where participants could provide details about their complaints, including the nature of the problem and personal information for follow-up purposes. Number of Participants: The ADT desk was manned by LSK Secretariat staff from the Compliance and Ethics department. During the event, nine members of the public visited the stand, expressing grievances against advocates. Most participants did not





have an existing advocate-client relationship,



and they sought assistance in understanding how to register their complaints.

Location: While the Legal Awareness Week took place in all High Court stations nationwide, the ADT desk was specifically stationed at Milimani Law Courts for its inaugural event.

Evaluation: The majority of

complaints raised during the event pertained to the withholding of funds, indicating a prevalent issue. A lower-than-expected turnout was observed, potentially attributed to factors such as insufficient funds, late budgeting, and limited advertisement or public awareness.

#### **Recommendations:**

- 1. Timely advertisement and public sensitization for future events.
- 2. Ensuring timely disbursement of funds and resources for event execution.
- 3. Deployment of staff to conduct and manage similar events in various branches.
- 4. Collaboration with other institutions, including Advocates Complaints Commission and Ombudsman, to gather ideas and assistance.
- 5. Encouragement of advocates to provide legal aid at the ADT desk during future events.
- 6. Motivation of staff and provision of basic necessities for desk operation.
- 7. Inclusion of ADT representation during Legal Awareness Week prison visits.

**Outcome:** A total of nine cases were recorded during the event, and these cases are currently being handled internally by the institution.

# 14 RECOMMENDATIONS AND NEXT STEPS
