The directive requiring mandatory replacement of registration plates for already registered motor vehicles at the expense of motor vehicle owners has no backing of the law, is arbitrary, irrational, unreasonable, unfair, punitive and generally ignorant of consumer rights and it was made without any or any reasonable public participation. Further, the impugned decision is afoul Articles 10, 47, 94 and 118 of the Constitution of Kenya 2010 and Sections 4 and 5 of the Fair Administrative Action Act, 2015.
