
Pursuant to regulation 32(1) of the Law Society of Kenya (General) Regulations 2020, the Law Society of Kenya (LSK) Elections Board 2024–2026 received and scrutinised the nomination papers submitted by members seeking various elective positions in the LSK elections scheduled to take place on 29th February 2024 for the positions of President, Vice-President, Members of Council, Male Representative to the Judicial Service Commission and Members of the Advocates Disciplinary Tribunal.

The LSK Elections Board 2024–2026 has approved the valid nominations of the members to vie for the various elective positions as indicated in the linked table, <u>Click here</u>

With respect to the position of representative of the general membership of the Society in the Council, who is an advocate of at least 25 years' standing, the LSK Elections Board 2024–2026 found that only one candidate, **K'Opere Tom Oduo** (P.105/2530/93), was validly nominated for the position. Consequently, in line with section 17(2)(c) of the Law Society of Kenya Act (No. 21 of 2014) and pursuant to regulation 34 of the Law Society of Kenya (General) Regulations 2020, the LSK Elections Board 2024-2026 has declared **K'Opere Tom Oduo** duly elected as a member of Council.

With respect to the position of member of the Advocates Disciplinary Tribunal, the LSK Elections Board 2024–2026 found that only three candidates, **Mutuma Kenneth Wyne** (P.105/4014/99), **Mwanyumba Eddah Majala**, (P.105/8146/10) and **Odiya Jane Nyabiage** (P.105/8568/11), were validly nominated for the position. STATEMENT / CMJA, CLA AND CLEA JOINT STATEMENT ON THE PUBLIC ATTACKS ON THE INDEPENDENCE OF THE JUDICIARY IN KENYA



The CMJA, CLA and CLEA (the Associations) are deeply concerned about the recent attacks on the independence of the Judiciary in Kenya including by the President of Kenya. The attacks follow judgments made by the courts in litigation challenging government decisions. We urge the Government of Kenya to respect the authority and independence of the judiciary and ensure that court decisions are respected and complied with and that due process is followed in line with the Kenya's constitution and its international obligations regarding any investigation of judicial officers for alleged corruption.

We support the Statements made by the Hon. Chief Justice, the Judicial Services Commission and the Law Society of Kenya of 2,3 and 4 January 2023.

Chapter I of the Commonwealth (Latimer House) Principles (2003) states: "Each Commonwealth country's Parliaments, Executives and Judiciaries are the guarantors in their respective spheres of the rule of law, the promotion and protection of fundamental human rights and the entrenchment of good governance based on the highest standards of honesty, probity and accountability." The Commonwealth Charter states in Chapter VI that: "We recognize the importance of maintaining the integrity of the roles of the Legislature, Executive and Judiciary. These are the guarantors in their respective spheres of the rule of law, the promotion and protection of fundamental human rights and adherence to good governance."
