



UPDATE - PROCESSING OF PRACTICING CERTIFICATES FOR THE YEAR 2024


Further to our Notice issued on 28th January, 2024, on Practicing Certificate applications, we wish to notify members of the progress in processing and issuance of Practicing Certificates for the year 2024.

As at 31st January, 2024, the Law Society of Kenya has so far received a total of 11,895 practicing certificate applications. Thereafter, the verification process is undertaken, which involves scrutinizing of all uploaded documents. Click <u>Here</u> to view the relevant attachments to upload and guidelines to the Practicing certificate application.

In the course of verification, the Secretariat has noted several inconsistencies, which mainly consist of incomplete, inaccurate or incorrect documents. These anomalies have been communicated to the respective members, for rectification. Kindly note that receipts and or practicing certificates will not be issued until regularization of the correct uploaded documents. Additionally, verification is a continuous process and members with outstanding issues will continue to receive assistance, to ensure the immediate resolution of any pending matters.

TYPES OF IT AUDIT

The various types of audits or areas where IT auditing is of importance include.

GENERAL IT CONTROLS AUDIT (GITC)

This includes an evaluation of an IT system's controls in the areas of access security, change management, interface and operations management, backup management, etc.

PROCESS OR POLICY AUDITS

These include audits or reviews of various IT processes and policies that exist within an organization such as ours.

CYBERSECURITY AUDIT

IT asset management audit, IT Portfolio management audit, etc.


COMPLIANCE OR REGULATORY AUDITS

These include audits where the objective is to review an organization's compliance to industry standards or regulations e.g. PCI DSS, ISO 27001 Audit, and SOX audit.

NOTICE FOR COMMENTS ON THE PUBLIC PARTICIPATION BILL (NATIONAL ASSEMBLY BILL NO:52 OF 2023)

The Public Participation Bill (National Assembly Bill No.52 of 2023) was read for the first time on **12th October**, **2023** and referred to the Committee on Parliamentary Broadcasting and Library for consideration.

The Bill seeks to provide a framework for effective public participation and to give effect to the Constitutional principles of public participation and participatory democracy as provided for in Articles 1, 10, 35, 69, 118,174,184,196, 201, and 232 of the Constitution.

In accordance with Article 118 of the Constitution and standing order 127(3), members are hereby invited to submit their comments on the Public Participation Bill. The Bill can be accessed through this <u>Link</u>.
