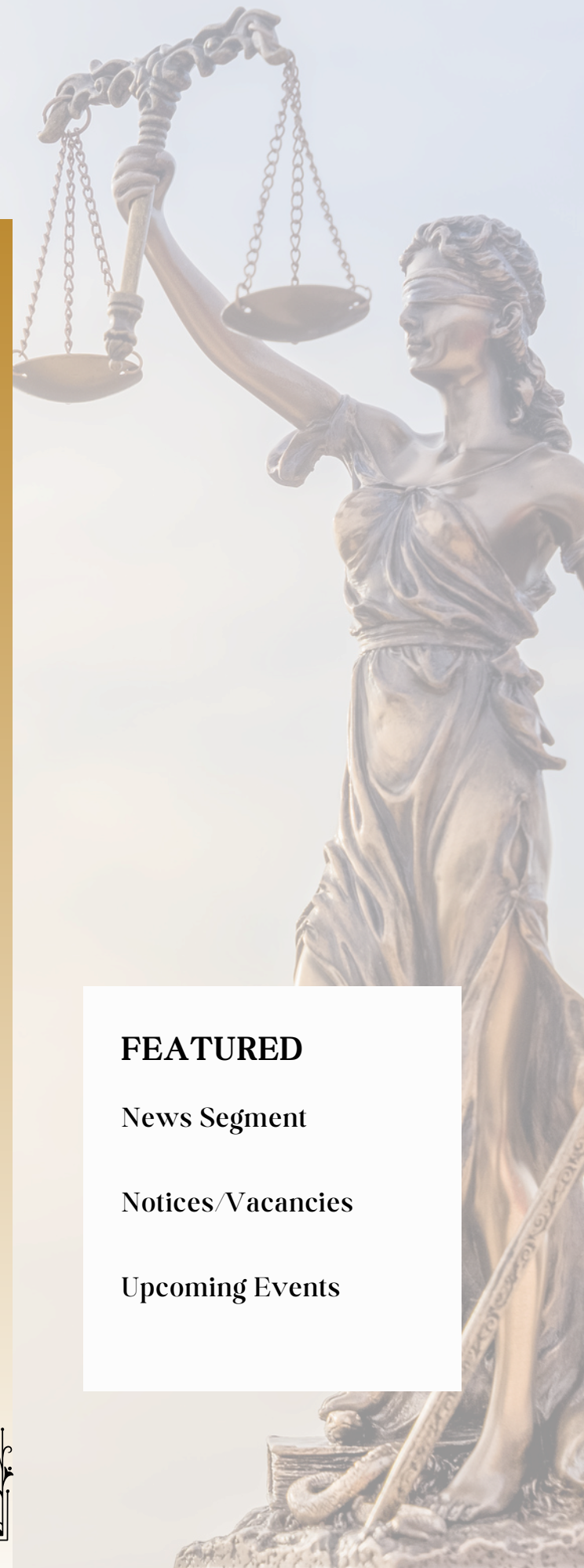

In her role as Convener of the Mothers of Victims and Survivors Network(MVSN), her unflinching bravery and astute leadership was inspirational.

## COURTESY CALL TO THE NATIONAL ASSEMBLY

The Council of the LSK paid a courtesy call to the Speaker of the National Assembly, Hon Moses Wetangula at the Parliament Buildings. The LSK President

Ms. Faith Odhiambo led the discussions, highlighting various areas of collaboration, which included legislative review, enhancement of public participation in shaping legislation & governance process, legal aid and capacity building for advocates in legislative drafting.

The LSK appreciates the for the National Assembly significant strides in the development of numerous legislations and hope to collaborate to further improve the legislative process.



## COURTESY CALL TO THE ATTORNEY GENERAL

The LSK President Faith Odhiambo led the Council to a Courtesy Call on the Attorney General (AG) Hon. Joseph Muturi at his Chambers at Sheria House.



The LSK presented a memorandum addressing some areas of concern while identifying possible areas of partnerships and collaboration. Some of the areas identified included Capacity Building on CPD, workshops & seminars, welfare concerns of State Counsels, especially on voting, enhancing the effectiveness and fair compensation of the members of the Advocates Disciplinary Tribunal (ADT), Public Interest Litigation and Law Reform among other areas.

The Council and the Hon. AG agreed to further their discussions on the identified areas of mutual interest.



## COURTESY CALL TO THE ODPP

The Council of the Law Society of Kenya, led by President Faith Odhiambo, flanked by VP Mwaura Kabata and Secretary/CEO Florence Muturi, paid the DPP Renson Ingonga a courtesy call at his office at the ODPP House.

The Council held the Courtesy call with a view to enhancing partnerships and collaboration between the two institutions. Some of the key issues discussed included legal education and training (CPD and training workshops), case management and prosecutorial practices, evidence handling, forensic procedures, and continuous work towards prosecuting unqualified persons acting as advocates, amongst others. The team agreed to work together in the various key areas of criminal justice reform with the aim of driving positive change and improving the administration of justice in Kenya.

The Auctioneers Licensing Board is established by Section 3(1) of the Auctioneers Act No. 5 of 1996. The term of one of the LSK Representatives to the Board has since expired.

## **NOTICE FOR COMMENTS ON THE TREATY MAKING AND RATIFICATION (AMENDMENT) (NO. 2) BILL, 2024**

The Treaty Making and Ratification (Amendment) (No.2) Bill 2024 was presented before the National Assembly for the First Reading on 20th March 2024 and referred to the Departmental Committee on Defense, Intelligence and Foreign Relations.

The bill seeks to amend the Treaty Making and Ratification Act, 2012, to incorporate a special enactment procedure for economic treaties, strengthen the National Assembly's participation in the treaty-making process, and enhance efficiency in the treaty-making process.

In accordance with Article 118 of the Constitution and standing order 127(3), members are hereby invited to submit their comments on the Treaty Making And Ratification (Amendment) (No.2) Bill 2024, which can be accessed through this [Link](#).

### **1. INDIVIDUAL ADVOCATE APPLICATIONS TO ESTABLISH A SOLE PROPRIETORSHIP**

#### **REQUIREMENTS:**

1. Preferred Name for registration. Note that the word 'advocates' must appear in the name. The name should be as it appears on the Roll of Advocates. Sole proprietors cannot use initials only.
2. The statement of particulars or proof of reservation certificate (BN) as obtained from the business registrar. (can be the screenshot of the name reservation page)
3. The name of the partner(s) to the outfit you are about to register.
4. The current PC (s) /receipt of payment

### **2. REQUIREMENT FOR REGISTERING LIMITED LIABILITY PARTNERSHIPS (LLPs)**

#### **REQUIREMENTS**

1. Preferred Name for registration. Note that the word 'advocates' must appear in the name.
2. Duly filled statement of particulars as per the LLP Act.
3. Proof of the reservation certificate (BN) as obtained from the business registrar.
4. The name of the partners to the outfit you are about to register.
5. The current PC (s) /receipt of payment for all partners

### COURSE OVERVIEW

#### 1.1 Introduction

The Kenya School of Law in exercise of its mandate invites applications from qualified persons to pursue the Certified Secretaries (CS) Course. The school receives intakes in January, May and September to align with KASNEB examination periods of April, August and December respectively.

#### 1.2 Why CS Course?

The CS qualification is a key requirement for qualification as company secretary, governance practitioner, governance compliance auditor and policy and governance consultant among other roles.

Upon successful completion the learner will be able to:

- Practice and promote principles of good governance within public and private sector entities;
- Implement and comply with legal, regulatory and ethical requirements in practice;
- Ensure proper conduct and management of meetings;
- Undertake consultancy and advisory services in corporate secretarial and related practices;
- Manage boardroom dynamics;
- Undertake governance and compliance audits.

### 2.0 FEE STRUCTURE AND DURATION

### 3.0 MINIMUM ENTRY QUALIFICATIONS

A person seeking to be registered as a student for the CS Course must show evidence of being a holder of one of the following minimum qualifications:

- (a) Kenya Certificate of Secondary Education (KCSE) examination with an aggregate average of at least grade C+ (C plus) or its equivalent.
- (b) Kenya Advanced Certificate of Education (KACE) with at least TWO Principal passes provided that the applicant has credits in Mathematics and English at Kenya Certificate of Education (KCE) level or equivalent qualifications.
- (c) KASNEB technician, diploma or professional examination certificate.
- (d) A degree from a recognized university.
- (e) International General Certificate of Secondary Education (IGCSE) examination grade C in 6 papers with C in both English and Mathematics.
- (f) Such other certificates or diplomas as may be approved by KASNEB.

The course will be delivered virtually between 1700hrs and 2100hrs on week-days and on Saturdays as shall be indicated on the timetable
