### LAW SOCIETY OF KENYA AND UK BAR PILOT MENTORSHIP PROGRAM: A YEAR OF GROWTH, LEARNING, AND FUTURE PROSPECTS

In 2023, the Law Society of Kenya (LSK) and the UK Bar entered into a Memorandum of Understanding (MOU) that birthed several collaborative programs, one of the most notable being the pilot mentorship program. This initiative aimed to connect young Kenyan lawyers with senior counsels from the UK, fostering a cross-cultural exchange of legal practices and professional growth.

#### The Journey and Impact of the Mentorship Program

Over the past year, ten mentees from Kenya were paired with ten senior counsels from the UK. This mentorship program has proven to be a transformative experience for both mentors and mentees, who convened virtually on July 16, 2024, to assess the program's progress and share their experiences. The discussions were enriching, with participants expressing how they have benefited from the mentorship in terms of professional confidence, exposure to international legal practices, and personal growth.

Notably, some mentees had the opportunity to meet their mentors in person during visits to the UK, further solidifying the mentor-mentee relationships. The program utilized mentoring program cards provided by the UK Bar, which helped guide the sessions and set goals-not just professional, but personal and family-oriented as well. However, flexibility was key, as some participants used alternative communication methods like WhatsApp to accommodate busy schedules.

The initiative's success owes much to the dedication of its project leaders, Mr. Bonface Were of the Law Society of Kenya and Ms. Amrit, leader of the Young Lawyers in the UK. The concept of this mentorship program was sparked over a lunch meeting between the two at the Radisson Blu Hotel, Nairobi. Both have been instrumental in steering the project to its successful culmination.

The program's convener at its inception was Mr. Byron Menezes, former leader of the Young Lawyers Committee. As the pilot phase concludes, Ms. Gloria Kimani, the current convener of the Young Lawyers Committee (2024-2026), has taken the reins, contributing significantly to the project's ongoing success. Special recognition is also due to Mr. Eric Theuri, President Emeritus of the Law Society of Kenya, whose vision and leadership facilitated the establishment of this platform.

#### Future Prospects and Acknowledgments

As the pilot mentorship program draws to a close, there is a growing consensus among participants on the importance of exposure and continuous learning. Recognizing the program's value, there is a proposal to establish a network of mentors and mentees. This network aims to maintain the momentum of the program, allowing current mentees to become mentors for new participants, thus creating a sustainable cycle of mentorship and professional development.

The Law Society of Kenya extends its gratitude to the mentors and mentees whose dedication and commitment have been central to the program's success.

### LSK CAMPAIGN TO WEED OUT MASQURADERS UNDERTAKEN IN NAIROBI

The LSK through the Practice Standards Directorate carried out an exercise to weed out Masqueraders in Kilimani subcounty.

The team, (the Council Members led by Ms. Linda Kiome, Convener, Practice Standards Committee assisted by a team from the Secretariat undertook an inspection of law firms at Ntashaart plaza. The inspection was necessitated by the reports that the secretariat had received concerning quack advocates operating in the area.

The inspectorate team managed to have Mrs. Edith Nambisia of Rabala Advocates apprehended for masquerading as an advocate. The suspect was arrested and booked at Kilimani Police Station awaiting arraignment in Court.







### PRACTICE STANDARDS DIRECTORATE- UPDATES

The LSK through the Practice Standards Directorate has been keen on ensuring compliance with the set laws, especially on matters of practice by investigating cases of non-compliance with the set rules.

**CONTRAVENTION OF ADVOCATES (MARKETING AND ADVERTISING) RULES, 2014** The directorate received a complaint against the law firm of CR Advocates LLP- for advertising its services on its YouTube handle contrary to The Advocates (Marketing and Advertising) Rules, 2014. Upon investigations, it was found that the firm had contravened Rule 5 (2) (b)(d) of The Advocates (Marketing and Advertising) Rules, 2014. It was noted that the firm's uploaded Video contravened the said sections, in that, the pictures of the advocates/partners were used and that the partner(s) thereof in the video were promising the public a particular outcome if they engaged them. The directorate acted on the complaint by demanding answers from the law firm in line with the LSK mandate.

Additionally, in the case of the firm Kaaya Memba & Company Advocates it was reported to have advertised on its Facebook page, a post purporting to promote debt collection services under their law firm contrary to Rule 5 (2) (d). In this case, the directorate also sent a letter to demand answers for their action.

NB: Advocates must adhere to the Advocates (Marketing and Advertising) Rules, 2014 in any form of publicity to their firm's business.

### **UNQUALIFIED PRACTICE**

A report was made to LSK on 17th July 2024 of Nawiri Justice Organization. The Organization purports to offer legal services to the public, they purported to do so through a pool of experienced Attorneys who navigate legal disputes, gather crucial evidence, and secure remedies thereof. Statutory checks established that, the entity does not exist as an NGOs nor as a law firm as presented in it website. The organization does not also have advocates declared to be working within it as the law prescribes. LSK has therefore recommended it ceases to provide legal services to the general public.

### MASQUERADES CASES UPDATES FROM THE COURTS

The LSK through the Practice Standards Directorate has been supporting in the prosecution of various cases in courts across the country that concern unqualified practice.

31st July 2024: Case Reference: R V Brenda Wangui -E751 Of 2023

This is a case of a masquerader who had been caught in Kerugoya town in November 2023 purporting to offer legal services through a law firm's defunct branch office. The matter was coming up for hearing on the said date. The Directorate's Program Officer and one Secretariat staff attended and testified in the case and produced letters/evidence in support. The case is set for further hearing on 9th September 2024 where two witnesses are set to testify.

### **UNQUALIFIED PRACTICE: EDITH NAMBISIA**

Similarly, a report was received by the Directorate of a Masquerader working within a law firm of Rabala and Co. Advocates in the Kilimani region, Nairobi area. Upon investigation, it was found that the law firm did not have an actively practicing advocate within its establishment. A stint operation was mounted by the Secretariat in the company of Ms. Linda Kiome -Council Member and Convener of Practice Standards and Ethics Committee on 31st July 2024. A result above-mentioned individual was arrested after purporting to render legal advice and for stamping documents on behalf of the Advocate who is not authorized to practice law. The suspect was arrested for the offenses and was being processed to take plea for engaging in an unqualified practice of law and the Advocate for professional misconduct for allowing his office to be utilized by an unqualified person is on-going.




### PARTICIPATION OF THE ABA BOARD AND STAFF AT THE LSK JUSTICE GAMES 2024

### A QUICK NOTE ON THE APPROVAL OF CABINET SECRETARIES

The constitutionally enshrined process of vetting of The President's second set of cabinet nominees, since he assumed power is currently ongoing in the National Assembly of Kenya. The process which has been scheduled for 4 days, comes at a time when Kenya is about to Celebrate the Katiba at 14 years since its promulgation. It is therefore an important season to reflect on the process of vetting of the Cabinet Secretaries.

The process is initiated by the President who writes to the Speaker of the National Assembly transmitting his nominations to the different offices of Cabinet. In this communication, the President attaches the curriculum vitae of the nominees which the Speaker has to publicly pronounce receipt of to the House. This is part of ensuring transparency in the appointment process as well as ensuring the Participation of Parliamentarians as representatives of the people in the appointive process. The second step in the process is then steered by the Speaker of the National Assembly who transmits the nominations to the National Assembly's Committee on Appointments for vetting.

The Committee on Appointments is established under the provisions of S.O. No. 204. It consists of the Speaker as a Chairperson, the Deputy Speaker, the Leader of the Majority Party, the Leader of the Minority party, the Deputy Leader of the Majority Party, the Deputy Leader of the Minority party, and not more than twenty-two other Members nominated by the House Business Committee, based on proportional Party Membership in the House taking into consideration the numerical strength of the Parties and interests of Independent Members. The mandate of the committee is espoused in Article 152(2) of the Constitution where it is supposed to consider for approval the appointments of Cabinet Secretaries.

The approval process is fashioned as a public interview process. In this process, the committee has to consider memorandums from the public against the appointment of individual nominees. Under Section 6(4) of the Public Appointments (Parliamentary Approvals) Act 2011, the Clerk of the National Assembly should have notified the general public of the intention of the Committee to hold public approval hearings seven days prior. The Clerk also invites the nominees to the approval hearing in writing and print media. Lastly, the Clerk also wrote to the Chapter 6 institutions such as the EACC, KRA, DCI, and HELB. The Registrar of political parties is also required to highlight any party affiliations as regards the nominees.



#### WEEKLY BITES

The current approval hearings have attracted 1300 memorandums against the nominees according to the National Assembly Speaker. Out of these, the committee has been highlighting several issues affecting the different ministries. Key among these issues have been matters that have been a thorn in the flesh for the public such as the legality of the Housing Levy, the rollout of the Universal health system in the country, the CBC curriculum rollout, the university funding, model, and the issue of extra-judicial killings among others. The nominees are also given an opportunity to responds to the memorandums in writing if they so wish. The process in itself is a good governance agenda where Article 10 principles are supposed to be depicted by the nominees as part of the constitutional principle of social contract. Lest we forget #Wakilis these are patriotism, and the rule of law, social justice, inclusiveness, human rights, accountability, and transparency to name a few.
