The matter was coming up for hearing on the said date and Council Member Stephen Mbugua and Embu Chapter officials testified in the case. The case is set for further hearing on 10th October, 2024 where other witnesses will be bonded to testify.

PAN-AFRICANISM AND THE AFRICAN UNION: WHERE IT BEGAN

"I am a border crosser, defying geographical containment. I am Zimbabwean, I am African, I am Pan-African, I am Nigerian, I am Jamaican, I am an internationalist, I am a Black American, I am trans-nationalist. I am a citizen of the world." According to the words of the late renowned civil rights activist [Prof. Micere Mugo](#) the ideals of the Pan-African movement are borderless.

The Pan-African movement should be viewed as a unifying movement for all Africans of the world. The historical perspective of Pan-Africanism maintains the common goal of the unity of Africans and the elimination of colonialism and white supremacy from the continent. The movement also encompasses such matters as leadership, political orientation, and national as opposed to regional interests as a movement for rapid continental social and democratic development. It is no surprise therefore that the movement found great credence in the late 19th Century at the advent of colonialism. It was during that period that the First Pan-African Congress, convened in London in 1900, which was followed by others in Paris (1919), London and Brussels (1921), London and Lisbon (1923), and New York City (1927). These congresses, organized chiefly by W. E. B. [Du Bois](#) and attended by the North American and West Indian black intelligentsia, did not propose immediate African independence; they favored gradual self-government and interracialism. However, in 1944 at the peak of the 2nd World War, several African organizations in London joined to form the Pan-African Federation, which for the first time demanded African autonomy and independence. It is from this Pan-Africanism as an intergovernmental movement was launched in 1958 with the First Conference of Independent African States in Accra, Ghana. At the time, Ghana and Liberia were the only sub-Saharan countries represented; the remainder were Arab and Muslim.

Thereafter, as independence was achieved by more African states, other interpretations of Pan-Africanism emerged, including the Union of African States (1960), the African States of the Casablanca Charter (1961), the African and Malagasy Union (1961), the Organization of Inter-African and Malagasy States (1962), and the African-Malagasy-Mauritius Common Organization (1964). It was at this stage that the African Union (AU) as we know it today was formed. It began in 1963 when the Organisation of African Union (OAU) was founded to promote unity and cooperation among all African states and to bring an end to colonialism. Notably, one of its longest commitments and greatest victories was the end of apartheid and the establishment of majority rule in South Africa. Efforts to promote even greater African economic, social, and political integration led to the establishment in 2001 of the African Union (AU), a successor organization to the OAU modeled on the European Union. The AU fully superseded the OAU in 2002, after a transitional period.

The AU is supported by the African Union Commission (AUC) a secretariat organ that supports the day-to-day activities of the Union. The AUC is governed by an African Country Elected chairperson who is also the Chief Executive Officer, legal representative of the AU, and the Commission's Chief Accounting Officer. He or she is directly responsible to the Executive Council for the discharge of his or her duties. The Chairperson of the Commission is elected by the Assembly for a four-year term, renewable once. Election is by secret ballot and a two-thirds majority of Member States are eligible to vote. Elections and terms are governed by the AU Assembly Rules of Procedure and the Commission Statutes. Kenya is currently fielding a candidate for the position and it's important for us as [#Wakilis](#) to have insights into the Pan-African agenda and how it is programmed into the AUC leadership.
