MEETING BETWEEN JUDICIARY AND THE BAR LEADERSHIP

On 18th December 2024, the Council of the Law Society of Kenya attended a meeting with the leadership of the Kenya Judiciary to address the issues bedeviling the judiciary and administration of justice. The meeting was convened in light of the recent overwhelming concerns over judicial misconduct and corruption, which has handicapped the effectiveness of Judges and Magistrates in the discharge of their judicial functions.

We noted to the leadership of the Judiciary that while the engagement was a welcome show of initiative, a piecemeal olive branch is far from what the Law Society of Kenya is willing or available to engage in. Accordingly, we insisted that today's deliberations must pave the way for drastic, full-scale changes in the operations of the judiciary and actions of judicial officers.

We asserted our bemusement with the uncanny laissez-faire with which the innumerable issues of Advocates and members of the public have been addressed, and we are encouraged that the Judiciary conceded that there are serious challenges within its ranks that must be addressed by all means necessary. In pursuit of the paradigm shift needed for the Judiciary to reclaim its place as an effective, independent arm of government capable of interpreting and upholding the Constitution, we put the Judiciary on notice over the LSK's unreserved resolve to shake the tree until all the bad fruit falls off.

Effective January, the LSK's committee on collection of complaints against Judges and Judicial Officers will commence its operations across the country to collate all complaints over incompetence, malpractice, and corruption by all Judicial Staff.

We undertake to pursue every credible complaint to ensure its just determination and conclusion. While we are prepared to support the JSC in its own efforts to clean up the mess, we remind them that they must take up their rightful place as a protector of the public, not a preservation scheme for rogue Judges and Magistrates. We are prepared and set to do all it takes to protect our judiciary because without it, the rule of law and our entire constitutional set up is doomed to collapse.

INSPECTION OF LAW FIRMS IN MOMBASA.

On 14th December 2024, the Practice Standards and Ethics Committee chaired by Ms. Lindah Kiome, Council Member undertook an Inspection of Law Firms in Mombasa. The operation was triggered by reports of malpractice within Mombasa City. The inspection was coordinated through Practice Standards Directorate and Officials from the Mombasa branch.

The team which included the Director Practice Standards and Head of Communication, with the support of police officers, was able to conduct a search in targeted offices. As a result of which a notorious individual (in a white T-shirt) purporting to be Advocate was arrested. STATEMENT OF THE PRESIDENT AND COUNCIL OF THE LAW SOCIETY OF KENYA

The Law Society of Kenya (LSK) stands at the forefront of upholding the principles of justice, accountability, and the rule of law within our nation. As 2024 comes to a close, it remains unfortunate that impunity and arbitrariness continue to reign over our country. This year has laid bare the dire state of our institutions, individually and collectively, and their vulnerability to the whims of an overbearing Executive arm of Government. We condemn the heinous acts that the National Police Service under the leadership of the Inspector General of Police, continue to perpetrate against the people of Kenya, in total violation of human rights, which they have a Constitutional duty to uphold.

We have received distress calls on the abduction of 2 Kenyans by police officers on 21st December 2024. We demand that police officers abandon and desist from these absurd, repressive tactics that have characterized 2024. We call for the immediate, unconditional release of Billy Mwangi and Peter Muteti, or that they be presented before Court to answer to whatever alleged charges on account of which they are being held as these abductions are contrary to the law and Article 49 of the Constitution of Kenya, 2010, which provides for the rights of Arrested Persons. In addition, we call upon the State, to observe, respect, protect, promote, and fulfill the rights and fundamental freedoms in the Bill of Rights as enshrined in Article 21 (1) of the Constitution of Kenya, 2010.

As we sustain our struggle for lasting change and full constitutional compliance, we appreciate that this festive season comes with more reflection than joy, and more preparation for the work ahead than jubilation over achievements past. While we have done good work in 2024, we continue to struggle through the difficulty of runaway impunity across sectors and institutions, amid a systemically compromised Judicial system. If our efforts are to bear results, a change in our Judiciary must be our foremost priority.

The apparent treatment of our Judiciary as an exclusive club for wealth creation and self-preservation of its members must cease. The Law Society of Kenya remains firmly committed to this undertaking, and is focused on leading Kenyans through an elaborate, objective and independent reevaluation and clean-up of the Judiciary. As we head into the

We call on every Kenyan with information and proof of unscrupulous conduct by Judicial officers, or evidence of assets and property believed to be proceeds of corruption to bring the same forward. The information can be shared on email to radicalsurgery@lsk.or.ke or president@lsk.or.ke. From January 2025, the Law Society will roll out select offices, through which Kenyans can bring further complaints and particulars relating to the Judiciary and Judicial officers.

The Judiciary is a source of livelihood for many, a source of hope for the potential of our country, and it is the repository of Justice for all. The duty to reclaim and guard it is, therefore, a collective responsibility we must all remain steadfast in. 2025 will be a year for transformation in the administration of justice. STATEMENT ON THE RECENT WAVE OF ABDUCTIONS IN KENYA

The Law Society of Kenya (LSK) is a professional statutory body established under the Law Society of Kenya Act, 2014, with the mandate to protect and assist members of the public in Kenya in matters relating to or ancillary or incidental to the law. Additionally, the LSK plays a critical role in assisting the Government and the courts in matters relating to legislation, the administration of justice, and the promotion of the rule of law.

In light of the recent spate of abductions across the country, the LSK expresses grave concerns over these alarming developments, which undermine constitutional guarantees and the security of all citizens. While we acknowledge the duty of state organs to maintain law and order, we reiterate the need to uphold human rights and adhere to constitutional and statutory requirements in all law enforcement efforts. The protection of fundamental freedoms, as enshrined in the Constitution, must remain central to any actions undertaken by state and non-state actors.

We express grave concern over the recent rise in abductions, enforced disappearances, and related human rights violations targeting individuals, specifically, social media users such as Billy Mwangi, Peter Muteti, Bernard Kavuli, and the reported detention of Gabriel Supeet at Ntulele Police Station amongst others.

In the face of this troubling trend, the Law Society urges families and close relations of the abducted individuals to come forward with comprehensive and accurate information regarding these incidents. This data will enable us to:

- Document the circumstances surrounding each case of abduction and disappearance.
- Initiate appropriate legal proceedings where rights violations have occurred.
- Facilitate advocacy at both national and international forums to hold perpetrators accountable.

We assure the public of our unrelenting commitment to ensure justice is served and to support the families during this challenging time. We encourage members of the public who possess credible information about the abducted individuals to report to the LSK Secretariat or any of our regional offices.

We remind the Government of Kenya of its solemn obligation under the Constitution of Kenya, 2010, particularly:

- Article 29, which guarantees the freedom and security of the person.
- Article 49, which ensures the rights of arrested individuals, including prompt presentation before a court of law or release on bond within 24 hours.

Any arrest or detention must strictly adhere to the rule of law and uphold the principles of transparency, accountability, and human dignity.

The state's silence and lack of accountability regarding the whereabouts of abducted individuals only serves to erode public trust and confidence in the government's capacity to protect its citizens. We demand an immediate disclosure of the location of the missing individuals and either their unconditional release or presentation before a court of law.

The statement by the National Police Spokesperson denying police involvement in these abductions calls for urgent clarity. If indeed the police are not complicit, it is incumbent upon them to:

- Investigate and prosecute those responsible for the abductions.
- Reassure the public by taking visible and demonstrable steps to protect citizens from further violations.
- Work collaboratively with other security agencies to restore public trust.

Failure to act decisively risks emboldening perpetrators and fostering a culture of impunity, which directly undermines human rights, constitutionalism, and the rule of law

It is insufficient for the Inspector-General of Police to merely deny police involvement in these abductions without explicitly outlining the steps being taken to address these egregious violations. The Inspector-General appears to lack awareness of his mandate under the law or the ability to discharge it effectively. This is a grave abdication of duty that cannot be countenanced in a constitutional democracy.

The office of the Inspector-General is entrusted with the responsibility to ensure the safety and security of all citizens. If the holder of this office is incapable of fulfilling that mandate, it would be in the best interest of the nation for him to either rise to the occasion and discharge his duties effectively or tender his resignation forthwith. Anything less would amount to a betrayal of the public trust and a dereliction of his constitutional obligations.

The Constitution of Kenya stands as the bedrock of governance, guaranteeing the rights, freedoms, and dignity of all individuals. The National Values and Principles of Governance under Article 10(2), including human dignity, transparency, accountability, and public participation, must guide all state actions, especially in addressing such serious breaches of public security.

The Law Society of Kenya calls for a national dialogue on enforced disappearances and a comprehensive strategy to combat these violations. As we continue to advocate for

LSK CONTINUING PROFESSIONAL DEVELOPMENT (CPD) COMPLIANCE (2024)

The Law Society of Kenya (LSK) encourages members to comply with The Legal Notice No. 43 - The Advocates (Continuing Professional Development) Rules, 2014.

The Rules provides as follows:

I) "CPD year" means a calendar year beginning on the 1st January and ending on the 31st December;

II) Rule 4: In each CPD year-

(a) An advocate shall participate in or attend approved events at which that advocate shall accrue a minimum of five units except where that advocate has been exempted in part or in whole;

(b) If an advocate accrues more than five (5) units, the excess number of units shall not be carried over to the next CPD year by that advocate

(d) In each CPD year, if an advocate fails to accrue five units, that advocate may make up the difference in the period between the 1st January and the 31st January of the next CPD year.

III) Rule 9: If an advocate fails to comply with these Rules-

(a) The Council shall notify the advocate in writing of the failure; and;

(b) The Council may require the advocate to inform the Council in writing within fourteen days of the Council's notice of that advocate's proposal to comply with these Rules.
