TARGETED FINANCIAL SANCTIONS NOTICE NO. 2 OF 2026

DELISTING FROM THE ISIL (DA'ESH) & AL-QAIDA SANCTIONS LIST

1 Background

- 1.1 The Prevention of Terrorism Act, 2012 (POTA) and the Prevention of Terrorism (Implementation of the United Nations Security Council Resolutions on Suppression of Terrorism) Regulations, 2024 (POT-TFR) provide for the implementation of targeted financial sanctions related to terrorism financing.
- 1.2 On 27 February 2026, the United Nations Security Council made updates to the ISIL (Da'esh) & Al-Qaida Sanctions List following the removal of an entry by the United Nations Security Council Committee pursuant to resolutions 1267 (1999), 1989 (2011) and 2253 (2015) concerning ISIL (Da'esh), Al-Qaida and associated individuals, groups, undertakings and entities.
- 1.3 Therefore, the assets freeze, travel ban and arms embargo set out in paragraph 1 of Security Council resolution 2734 (2024), and adopted under Chapter VII of the Charter of the United Nations no longer apply to the delisted person(s).
- 1.4 Pursuant to Regulation 13(3) of POT-TFR, the Counter Financing of Terrorism Inter-Ministerial Committee hereby circulates the delisting notification to Reporting Institutions, the Public and any other person who

may be holding targeted funds or other assets of the delisted person; and provides guidance on actions to be taken following receipt of this Notice.

2 Delisted Entries

2.1 The removal from the ISIL (Da'esh) & Al-Qaida Sanctions List relate to the following entry: -

- **QDe. 137 AL-NUSRAH FRONT FOR THE PEOPLE OF THE LEVANT**

2.2 More details on the delisted person(s) are provided in *Annex 1*.

3 Action to be taken

3.1 Based on the information, review whether you had undertaken a freezing action on targeted funds or other assets pursuant to resolutions 1267 (1999), 1989 (2011) and 2253 (2015) concerning the delisted person(s).

3.2 Respect the delisting and unfreeze, without delay, all targeted funds or other assets of the delisted person(s) that you or your institution holds.

3.3 Upon effecting the unfreezing action or taking any other action, file a report to the Counter Financing of Terrorism Inter-Ministerial Committee through the Secretary to the Committee via tfs@frc.go.ke, specifying the action taken. This includes circumstances where you conduct screening and identify a positive match.

- 3.4 For a De-Listing Notice, if no positive match is found, you are not required to submit a “nil” return, unlike Listing, Amendment, and Re-Listing Notices, where you are required to submit a “nil” return.
- 4 Non-compliance with the provisions of the obligations provided in this Notice, or attempts to circumvent the provisions is an offense under the POT-TFR.

Security Council ISIL (Da'esh) and Al-Qaida Sanctions Committee Removes One Entry from Its Sanctions List

On 27 February, the Security Council Committee pursuant to resolutions 1267 (1999), 1989 (2011) and 2253 (2015) concerning ISIL (Da'esh), Al-Qaida and associated individuals, groups, undertakings and entities removed the entry below from the ISIL (Da'esh) and Al-Qaida Sanctions List.

Therefore, the assets freeze, travel ban and arms embargo set out in paragraph 1 of Security Council resolution 2734 (2024) and adopted under Chapter VII of the Charter of the United Nations, no longer apply to the name set out below:

information: Associated with Al-Qaida (QDe.004). Brought Syrian and foreign Al-Qaida in Iraq (QDe.115) and Asbat al-Ansar (QDe.007) fighters, along with other foreign Al-Qaida operatives, to join local elements in Syrian Arab Republic to carry out terrorist and guerrilla operations there. Previously associated with the Islamic State in Iraq and the Levant (ISIL), listed as Al-Qaida in Iraq (QDe.115), and its leader Ibrahim Awwad Ibrahim Ali al-Badri al-Samarrai (QDi.299) but separated from that group in 2013. In Jul. 2016, Abu Mohammed Al-Jawlani (QDi.317), the leader of Al-Nusra Front for the People of the Levant, announced the group had

changed its name to Jabhat Fath al-Sham and was no longer affiliated with any external entity. Despite the announcement and attempts to distinguish itself from Al-Nusrah Front for the People of the Levant, the group remains aligned with Al-Qaida and continues to carry out terrorist operations under this new name. In January 2017, Al-Nusrah Front created Hay'at Tahrir al-Sham (HTS) as a vehicle to advance its position in the Syrian insurgency and further its own goals as Al-Qaida's affiliate in Syria. Previously listed between 30 May 2013 and 13 May 2014 as an aka of Al-Qaida in Iraq (QDe.115). Review pursuant to Security Council resolution 2368 (2017) was concluded on 15 November 2021.
